7. QUESTIONS AND STATEMENTS

The following questions were responded to –

- I. Response in respect to a question sought by Hon. Alfred Mukhanya on the environmental and health menace being experienced by the residents of Ndivisi Ward living close to Makemo dam.

On why the Department has neglected the said Dam posing a risk to human life and other environmental and health risks to the residents of Ndivisi the CECM responded that Makemo dam is the largest in the County with a capacity of over 100,000M² of water. The dam has a huge potential for irrigation and fisheries and fisheries development as well as recreation. In spite of the dam being an important resource, it has been neglected because the local leadership and the community have not given it priority while choosing projects to be funded by the County Government just like in the case of other dams and water pans across the County.

On the reasons as to why there has been little effort to rehabilitate the dam-the CECM submitted that owing to its large capacity, it falls under the department of water. This is because the department of Irrigation which is under the County Ministry of Agriculture, Livestock, Fisheries, Irrigation and Cooperatives is only allowed water pans and small dams of capacity of less than rehabilitation. This amount is enormous and hence requires proper planning and resource mobilization similar to what happened to Kabkara Dam which is being rehabilitated by the Nation Agriculture and Rural Inclusive and Growth project (NARIGP).

On the steps the Executive is taking to implement the recommendations of PAC/PIC report in respect of rehabilitation of the said dam done in the Financial year 2014/2015-The CECM responded that the issue of the said report and its implementation can only be clarified by the County Secretary who was there at the said time, and the implementation committee of the first County Assembly. This is because the implementation of the reports has a time frame and is depended on the due diligence that is done by the Executive on issues raised in PIC/PAC reports.

On what the department is doing to have the dam repaired in a better manner-The CECM responded that the department in its planning framework, the Draft Sectoral plan 2023-2032 and the draft County Integrated Development Plan (CIDP) 2023-2027, has planned to rehabilitate dams across the County. has planned to rehabilitate dams across the County to increase water storage capacity and availability for increased agricultural and fisheries productivity. But the rehabilitation will be done in phases due to limited resources.

The availed response was satisfactory.

II. Response on a question sought by Hon. John Wanyama in relation to Muyayi Vocational Training Center.

On when the center was commissioned

The CECM replied that Muyayi VTC located in Bukembe West was started in 2016 on 0.45 hectares of land.

On why the greatly marketable courses like masonry, plumbing and electrical are not being offered in the institution

The CECM answered that Masonry and plumbing are licensed and are marketable but no student enrolled. Electrical course is not offered because the institution has no electricity and also the VTC has no qualified instructor in electrical engineering to teach electrical course.

On why the center offers tailoring, food and beverage course and only one tutor has been posted there

The CECM responded that the center does not offer only the aforementioned courses. Other courses offered are hair dressing, plumbing, and masonry which have instructors.

On what the Department is doing to have the VTC well-equipped of both personnel and various courses for trainings so as to attract more students-The CECM replied that the department will allocate student bursary of which the school management will use part to equip the center.

The response was satisfactory.

III. Response in regard to a question sought by Hon. Johnstone Ipara in relation to lack of clear information as far as the current status of Tongaren and Milimani VTCs are concerned (question no.45/2023).

On how many instructors have so far been deployed on permanent and pensionable terms in Tongaren and Milimani VTCs

The CECM responded that in Tongaren VTC has a total number of 4 instructors while in Milimani VTC has 3 instructors.

On what is the current number of students and the capitation that the students are allocated in the aforementioned VTCs?

The CECM responded that total number of students in Tongaren VTC is 41 with a capitation of Kshs. 113,000 while the total number of students in Milimani VTC is 74 with a capitation of Kshs. 126,000.

On what are the courses that are offered in the mentioned VTCs?

The CECM replied that in Tongaren VTC the courses offered are: Garment making, motor vehicle mechanics, Electrical, Masonry, Hair dressing and ICT. Whereas in Milimani VTC the courses offered are: Motor vehicle

mechanics, Building Technology, Agriculture/Agribusiness, Fashion and design and ICT.

On the development projects that have been done so far in the said VTCs from FY 2018/2019 to date. Provide the names of the contractors, the cost and the amount spent on those project

The CECM replied that Tongaren VTC was constructed in the FY 2020/21 by Chikhabe Enterprises. The projects is complete and, in the use, though finishing was poor especially the ceiling, painting was poorly done and the floor is cracking.

Milimani VTC, one classroom that was budgeted in the FY 2017/18 was awarded to Renbic Building and Construction Company Limited who completed the project and it is in use. The contractor also constructed one ECDE classroom and pit latrine at Makololwe and Mabusi primary schools. The total project cost for the three classroom and pit latrine was Kshs. 6M

Availed response was not satisfactory.

IV. Response in regard to the question sought by Hon. Johnstone Ipara on the scant information on the roads done in the financial year 2019/2020.2020/21 and 2021/2022.

Response was not availed on the floor of the House, the CECM Roads, Transport, Infrastructure and Public Works to issue the response before the House on 27th June at Two O'clock in the afternoon.
