#### DEPARTMENTAL EXPENDITURE ANALYSIS

In the financial year 2020/21, the department of Gender and Culture had an annual approved budget of Kshs.82, 581,530 comprising of Kshs. 75,717,631 recurrent and Kshs. 6,863,899 for development expenditure programmes.

#### **Exchequer Releases**

A total of Kshs. 5,696,680 was released in the month of September in the first quarter of the financial year.

#### **Detailed Personnel Expenditure**

The department spent Kshs. 5,296,680 to pay salaries for the three months under review all paid in the month of September.

#### Pending Staff Receivables (Outstanding Imprests)

The list submitted by the County Treasury indicated Kshs. 1,526,000 as outstanding imprests for both Gender and Culture and Youth and Sports. The Department of Gender and Culture submitted a list of outstanding imprests for office imprest amounting to Kshs. 400,000 which were indicated as surrendered.

#### Budget execution by programmes and sub-programmes

The budget execution by programmes and sub-programmes as submitted by the department is outlined in the table below:

As at 30<sup>th</sup> September 2021, the department had utilized a total of **Kshs. 5,696,680** on recurrent equivalent to 6.9% of the approved annual budget and none on development.

### Budget Implementation reports. (Programmes implemented in the period under review as per the approved PBB and activity costing.

The report gives the expenditures of the programmes implemented below .The programmes were however not broken down to specific activities implemented to determine whether funds were spent on approved activities and work-plans or if there was deviation.

#### Use of goods & Services constitutes the expenditures below:

- a) Daily Subsistence allowances and accommodation; Kshs.200,000
- b) Field Operational Allowance; Kshs. 200,000

Notably all the other votes remained unspent during the first quarter.

#### **Pending Bills/ Accounts Payables**

The department did not submit a breakdown of pending bills for the first quarter.

#### **Development**

The department had an allocation of **Kshs.6**, **863,899** for development which was not spent by the end first quarter of the financial year.

#### COMMITTEE'S OBSERVATIONS AND RECOMMENDATIONS

#### **Committee Observations**

The committee made the following observations:

- 1. The committee noted that the document submitted by the County Treasury provided a breakdown of the expenditures by programmes and sub-programmes per department, thus it was easy to highlight the expenditures for each department during the first quarter.
- 2. The department utilized Kshs. 5,696,680 representing 6.9% of the total allocation for the year during the first quarter. The funds were used for payment of salaries, daily subsistence allowance and for field operational allowances
- 3. The department declared un-surrendered imprests during the period under review amounting to Kshs.400, 000 which had not been cleared by the County Treasury by the time of production of this report. The committee noted that the imprests were issued as office imprests meant for office operations.
- 4. The committee noted that the department did not submit a breakdown for the activities implemented under the program.
- 5. The department did not submit the approved work plan for the financial year. In the absence of the work plan the committee could not ascertain whether the budget was implemented in line with the approved plans.

#### RECOMMENDATIONS

- 1. The committee recommended that the department of Gender and Culture should submit the approved departmental work plan for the FY 2021/2022 to the County Assembly within fourteen (14) days of adoption of this report. This will guide the committee in the analysis of subsequent financial statements and quarter reports in the financial year.
- 2. The Accounting Officer should within fourteen days (14) of adoption of this report; submit a breakdown of the expenditures on salaries, daily subsistence allowance and for field operational allowances spent during the first quarter of the financial year.
