# COMMUNICATION FROM THE CHAIR

I have communication to make. I have some three Communications to make:

One, I read concerning the Vacancy in Khasoko Ward and a caretaker Honourable Member.

Honourable Members, following the Death of Hon. Daniel Sitati Makhandia, MCA of Khasoko Ward, and following the formal gazzettment of the Vacancy to the said Ward via Gazette notice number 704 of 28<sup>th</sup> January, 2022 and I read:

To the Independent Electoral and Boundaries Commission

Khasoko Ward

Whereas the Vacancy has arisen in the office of a Member of the Bungoma County Assembly in respect of the above mentioned Ward. Now therefore, in pursuant to the provisions of Section 19(iii) of the Elections Act 2011, I command that due to Notice being first given you do cause election to be held according to the law of a member to serve to the County Assembly for the said Ward.

Dated 15<sup>th</sup> January, 2022.

Now Honourable Members, the Office of the Speaker has nominated Hon. Hamphrey Sifuna of Bumula Ward to oversee and take care of the operations of Khasoko Ward in the meantime, until the elections are held for the said people to elect their representative to the County Assembly of Bungoma by the Independent Electoral and Boundaries Commission.

(Applause)

It is accordingly directed.



Two, we do have visitors in our Public Gallery from Mitua Girls High School, being students of History accompanied by their teachers. I will call the names of the teachers and as I call the name, teachers be upstanding:

They are led by Mr. Wanjala Jimmy, Mr. Mark Simiyu, Esther Siboe, Dan Wanambisi, Kibet Joshua. All the teachers be upstanding, and all the Students be upstanding.

(The teachers and students stood in their place in the Gallery)

Honourable Members, let us applaud them.

# (Applause)

Honourable Members, during Statement Hour, the Hon. Fred Musebe will represent the MCA Soysambu Mitua Ward in making a remark about this School and other two Honourable Members, a Male and a Female to also make short remarks about the School.

You can now get seated.

Three, Honourable Members, the Office of the Speaker had received three amendments for consideration in respect of the First Supplementary Statements for financial year 2021/2022 which were within the required timelines as per the Standing Order number 52. They were from Hon. Francis Maasai Chemion, Leader of Minority Party, The Hon. Majimbo Okumu, Chairperson - Committee on Public Administration and ICT, The Hon. Luke Opwora, Chairperson - Youth Committee which were subsequently withdrawn.

# (Applause)

Similarly, at exactly 2:30 before... Hon. Opwora! Order Honourable Members, Order Honourable Members!! Hon. Opwora and Mukhongo get seated. Well.

Order Honourable Members! Order!

# (Loud Consultations)

Similarly at 2:30 p.m. in my office...Order! Order! Honourable Members you need to be orderly. Honourable Members, I'm going to invoke the provisions of this House when we do not put acts according to the standards and tenets of this House. If you must speak, we know very well that you have to speak through the Speaker. So it is very absurd when we start shouting without going through the required Standards.

Similarly at exactly 2:30 p.m. before I entered this plenary, I received an amendment from the Hon. Barasa Mukhongo which in this case has not adhered to the requirements of the Standing Orders number 52(i). In this case, this amendment cannot be considered since it breaches the very rules of this House because we know...

#### (Applause)

...that the amendments should reach the Office of the Speaker 2 hours before the commencement of the session.

I therefore decline to allow this.

#### (Applause)

Hon. Opwora, before I give you a chance to speak, I want to inform you that you are not going to question the decision of the Speaker. If you are standing on any point of order questioning my authority, Hon. Opwora you will be out of order.

#### (Applause)

Honourable Members let us hear him.

**Hon. Luke Opwora:** (*On a point of Order*) Mr. Speaker, I don't like this intimidations from my colleagues. It does not mean that when you are young, you are disabled. No, you cannot start intimidating me for I'm representing the youths of this County, I was brought by FORD Kenya and I must speak. Yes! Mr. Speaker.

Mr. Deputy Speaker: Order Honourable Members. Order!!

**Hon. Luke Opwora:** Mr. Speaker my point is one and I sit down. When did I bring withdrawal of my amendment?

#### (Loud Consultations)

Mr. Deputy Speaker: Resume your seat first. Resume your seat!

Hon. Luke Opwora: No!

**Mr. Deputy Speaker:** Honourable Members, when you rise up on a point of Order, stick to the point of Order. Do not digress from the same.

**Hon. Henry Majimbo:** Mr. Speaker, I was once the age of Hon. Opwora when I was first nominated as a Counselor. I recall I had a confrontation with a District Commissioner, but I have grown of age. I have to guide. I know my son. Hon. Opwora is disturbed by your communication but I want to beseech you that this is not the end of the transaction you wanted to transact to this House.

I want to beseech you to respect the Speaker so that the Speaker can also respect you. I don't wish the Speaker to invoke the provision of our Standing Order number 104. It will be in bad taste especially this electioneering year that Hon. Opwora was suspended or expelled from the House.

I want to beseech you as my son that please, let the Speaker not take that direction. This is not the end of the road for all the transactions. Thank you.

# (Applause)

Hon. Jack Wambulwa: I want to inform my colleague Hon. Opwora. Yes he is a youth.

Mr. Deputy Speaker: Order! Please consult in low tones.

**Hon. Jack Wambulwa:** Yes we know, he is a youth nominated by Ford Kenya to represent the youths but I don't think in this Assembly, we are representing party issues. We are legislating as leaders and it is about the supplementary of this House.

# (Applause)

I therefore request my colleague that FORD Kenya as a Party is not a party that makes noise. It is a party that moves quietly to the people and it addresses the matters that affects the common Mwananchi. I request him to be slow if he wants to reason with this House. There is a better way of reasoning but not shouting.

# (Applause)

**Hon. Joseph Nyongesa:** First, let me appreciate the following seniors. As leaders of this House, we have been consulting. Today evening, I had time to consult with my colleague Hon. Chemion who is the leader of Minority and we agreed. I also extended my hand to our senior most Hon. Henry Majimbo and did consultation. We agreed.

Furthermore, as I was through with Hon. Majimbo and Hon. Meshack Museveni, we were with Hon. Opwora and we consulted. I reported to you. I was so shocked and I know may be it was just a push from Hon. Mukhongo, that is why maybe Hon. Opwora has behaved the way he has behaved.

As seniors, we are there to forgive but sometimes don't push us so much so that we at least look at him as if he is not obedient.

Otherwise, I greatly appreciate those Members who had petitions and agreed to ensure that the Government will get more figure.

**Mr. Deputy Speaker:** I think those sentiments are more than enough but because of Gender sensitivity, I want to give a chance to Hon. Jane Chebet.

Hon. Jane Chebet: Mr. Speaker,

It is our time to be here and it will come a time for you to be here if you will be doing the right thing. So that is my piece of advice. I wish to submit it and thank you so much teachers and students for choosing to come here.

Mr. Deputy Speaker: Thank you, Hon. Fredrick Musebe.

**Hon. Jane Chebet:** Thank you for giving me this opportunity. I want to address the students and teachers of Mitua School. Having come from a background of teaching, coming to be a legislator here in the County Assembly, I want to encourage the teachers of the school that we teachers should not just take teaching as the final stage in our profession.

Legislation can also be another stage in your life. I would like to encourage my fellow teachers to venture into browner pastures for it is no longer greener pastures. **Mr. Deputy Speaker:** Thank you, Hon. Joan Lutukai. Now, Honorable members as we finish that part, this school is the school that...Hon. Aseneka is a neighbor coming from Tongaren Sub County and close to the school.

I give you chance to make a remark!

**Hon. Nathaniel Aseneka:** Thank you, Honorable Speaker. Actually I could have felt bad if I would be left out but thanks for allowing me to at least give a remark.

On the onset, I am the direct or the immediate neighbor to this school and that one tells us that I am a direct beneficiary in terms of enrolment to this particular school. I have a number of students who come from Ndalu who school in this good girls' school. I thank the teachers who

thought it wise that they come to learn more about devolution because when we were here, these are the fruits of devolution.

This school has set a land mark. Why do I say so? The Chief Officer, Education, Madam Rose Murunga left this school to join the County Government as a Chief Officer so the school has really brought us a person who is doing so well in terms of managing matters Education. This one already tells us that the school has people with a lot of potential.

I want to extend my thanks to the administration of the school and all that are concerned in matters discipline. I do not remember at one given time having heard or witnessed unrest in this particular school. We have had school fires and so forth but I have never had any from this school and I keep praying that let us kindly take it up, improve our discipline so that we do not get to that level whereby we destroy our own schools. So let me not labor so much on it.

I wish you all the best as we head to the exams. I know you have been performing and I wish that we improve that performance. You have always made us proud. Thank you so much.

**Mr. Deputy Speaker:** Thank you, Honorable members. That is the last speaker on making a remark about Mitua Girls. I want to take this opportunity to wish this very wonderful students and teachers all the best as they prepare for the final examinations which is KCSE coming in March. May God bless you as you travel back home. Thank you, so much.

**Hon. Henry Majimbo:** Mr. Speaker, I have been directed by my whip to second and having invoked the provisions of Standing Order 104 grossly disorderly conduct. If the member concerned, the conduct is grossly disorderly if the member concerned creates actual disorder. You know we ask ourselves, was actual disorder here? If it is yes we say yes. Was he using threatening violence against a member or any other person?

Persist in making serious allegations without the Speakers opinion adequate substantiation.

Honorable members, the matter having been brought to the attention of the Speaker, a gross disorderly conduct having been observed and Hon. Opwora Luke having been named Honorable members under Standing Order 105(1) (a) and 106, the Honorable member Luke Opwora is therefore suspended from the services of the County Assembly for the entire period of today and tomorrow from the precincts of the County Assembly and the Serjeant-at-arms to enforce the orders and to have Hon. Luke Opwora out of the precincts of The County Assembly and when he comes back on Thursday flanked by two leaders of his party to offer an apology to this House failure to which it will attract more penalties on his conduct. 

DEPARTMENT OF AGRICULTURE, LIVESTOCK, FISHERIES AND CO-OPERATIVES DEVELOPMENT

**Hon. Joan Lutukai (Chairperson, Agriculture):** Thank you, Madam Chair. This is the Department of Agriculture, Livestock, Fisheries and Co-operatives Development. Honorable Chair, under Standing Order number 216(1) I stand to move that the sum of Ksh. 147,656,490 be issued from the County exchequer account to meet the expenditure during the year ending 30<sup>th</sup> June 2022 in respect of the recurrent expenditure of Ksh 17,318,490 and development expenditure of Ksh 130, 338,000 in the Department of Agriculture, Livestock, Fisheries and Co-operatives Development.



Now honorable members, we have concluded the second reading of the same and therefore having adopted the report of the first supplementary budget pursuant to Standing Order 132 (1) I direct that the 3rd Reading on the First Supplementary Appropriations, Bill 2022 shall be done tomorrow in the morning session together with its Appropriations Bill. There being no other business, we adjourn to tomorrow at 9:30 a.m.
