First of all, I want to thank the teachers who have accompanied these students and coming all the way from the other side of the country to come associate with Bungoma environment and to also learn a lot from this county assembly. #### CHAPTER TWO

# DEPARTMENTAL ANALYSIS DEPARTMENT OF LANDS, URBAN AND PHYSICAL PLANNING 1ST QUARTER EXPENDITURE FY 2021/2022

The department received a total exchequer Of Kshs. 6,982,330 in the first quarter for its recurrent expenditures. No release was done in favour of development expenditures.

Personnel budget had a total expenditures of Kshs. 6,062,330 representing an absorption of Kshs. 23.4% of the budgeted amounts.

July-Kshs. 2,084,630

Aug-Kshs. 1,988,850

September-Kshs.1, 988,850.

The salary for the month of July was more with 31 members of staff compared to the other two months with 3 members of Staff the reason submitted by the Chief Officer is due to retirement of Mr. Isaac Alinyo Okaka from service.

Implementation of development projects had not commenced in the 1st quarter including the pending bills of 4 million for the kimetics equipment. The total amount on pending bills as at 30th June was Kshs. 13,379,760 exclusive of 4 million for the kimetics equipment. The total amount of Pending bills in the department amounts to Kshs. 55,671,305.12 and this includes pending bills for the ward based projects worth Kshs. 42,291,525.12 Outstanding imprest

Development Expenditure

The department has the approved budget of Ksh. 21,700,000 (development) to undertake the following development programs in the FY 2021/2022

- □ Other Infrastructure and Civil Works 9,700,000
- $\Box$  Purchase of survey equipment's 4,000,000
- $\Box Acquisition of Land 8,000,000$

During the period under review, the department did not undertake any development project.

Budget execution by programmes

The department spent a total of Ksh. 1,914,885 out of which Ksh. 1,344,085 on salaries and Ksh. 570,800 spent on other operations in the department.

#### Outstanding Imprest

The department had 2 imprest relating to the following activities:

SUED (Sustainable Urban Economic Development) launch -Ksh. 520,000. However, the activity was not captured in the approved Programme Based Budget at the same time SUED is a UK-AID grant domiciled in the Municipality of Bungoma.

The Chief Officer justified that the facilitation for finalization of County Urban Development Plan policy at the cost of Ksh. 630,500 was on advanced stage and the report was at the cabinet level awaiting recommendations and subsequent forwarding to the County Assembly for approval.

Committee recommendations

- I. The Chief Officer department of Lands, Urban and Physical Planning should revise the department's procurement plan and capture the following programmes that were not achieved in the 1st quarter. The programmes are:
  - □ Purchase of Land for WARD Based Projects
  - $\Box$  Purchase of Land for Land bank
  - □ Acquisition of land for Kapsokwony fire Station
- II. The pending bills amounting to Ksh. Ksh. 13,379,760 and Ksh. 4 million for the kinetics equipment should be considered and be paid as per the approved Budget FY 2021/2022
- III. The total amount of Pending bills in the department amounting to Ksh. 55,671,305.12 including pending bills for the ward based projects worth Ksh. 42,291,525.12 should be implemented as per the approved Budget FY 2021/2022
- IV. The Chief Officer should within 30 days after adoption of this report submit to the committee a certificate of imprest surrendered on the following imprest:
  - □ SUED (Sustainable Urban Economic Development) launch -Ksh. 520,000.
  - $\hfill\square$  The facilitation for finalization of County Urban Development Plan policy at the cost of Ksh. 630,500

#### PART FOUR: DEPARTMENTAL EXPENDITURE ANALYSIS

- 1. The department of Trade, Energy and Industrialization had an annual approved budget of Ksh. 140,890,813 comprising of Ksh. 58,486,816 recurrent and Ksh. 82,403,997 for Development expenditure programmes.
- 2. The department submitted reports on how it performed during the period under review in terms of expenditure. The department also submitted its implemented programmes broken down into activities for ease of understanding and subsequent oversight by the committee as per the approved budget.
- 3. Pending staff receivables (outstanding imprest holders) in the department is Ksh. 1,624,360. Out of the total County outstanding imprest for all the departments amounting to Ksh. 117,087,185 as at end of the period under review.
- 4. Budget execution by programmes and sub-programmes as indicated of the submitted document indicates that the department spent a total of Ksh. 5,028,061 in the period under review. Ksh. 4,228,061 was spent on salaries while Ksh. 800,000 was spent on other operations of the department.

#### PART FIVE

#### (A). COMMITTEE FINDINGS

- 1. The County treasury did not indicate how much each department received as revenue (Exchequer Issues) to implement their programmes in first quarter.

- 2. The executed specific activities to which the Ksh. 800,000 spent on operations were not shown to disclose the detailed information on the actual budget implementation of the department.
- 3. Departmental monthly/annual work plans and the budget implementation status report were not submitted to the committee for comparison purposes with the financial report.
- 4. Notes as to how the outstanding staff imprest would be surrendered or recovered were not indicated in the report.
- 5. The report does not outline specific projects implemented by the department in the period under review, to enable the committee carry out its oversight role.

#### (B). COMMMITTEE RECOMMENDATIONS

- 1. The County treasury should be submitting additional information on how much each department received as revenue (Exchequer Issues) to implement their programmes in the respective departments.
- 2. The department should within 21 days after adoption of this report furnish to the committee a report on the specific activities to which the Ksh 800,000 was spend on operations, this will assist the committee in playing its oversight role on approved programmes.
- 3. The Chief Officer department of Trade, Energy and Industrialization should be submitting Departmental monthly/ annual work plans and the budget implementation status report for scrutiny and approval on time as it's required in the PFM ACT.
- 4. The Chief Officer, Department of Trade, Energy and Industrialization should within 21 days submit to the committee Imprest surrender clearance certificates for the imprest holders amounting to Kshs.1, 624,360 for verification.
