On behalf of Housing and Sanitation Committee and on behalf of the Kenya Kwanza team who are seated here, I may move this motion about implementation status of the work plan for the FY 2020/2021 and 2021/2022 in respect to the department of Housing and Sanitation.

On page 3 is the list of members of the committee who Honourable Members know. I also beg to skip.

Allow me to also extend my appreciation to all members of the committee for their commitment during the consultative meetings and report writing exercise on the implementation status of the Annual work plans for the department of Housing and Sanitation in the FY 2020/2021 and FY 2021/2022 respectively.

Implementation status of the Annual work plan in the department for the FY 2020/2021, 2021/2022

### HOUSING DEPARTMENT WORKPLAN FOR 2020/2021-

The implementation status of the Annual Work Plan.

Mr. Speaker Sir, during the interrogation exercise, the committee on Housing and sanitation noted that the activities under recurrent in the department of Housing included the following;

1. Updating of housing inventories to be done on quarterly basis.
2. Physical assessment of two houses
3. Formulation of the Housing Policy.
4. Minor repairs of two houses opposite the High Rise building

During the year under review, the department set out to renovate various Houses across the County as part of their development plan.

The department managed to renovate 13 houses which are renovation of nine houses in Kimalewa health centre, four houses at Bungoma Referral Hospital, one house at upper and one house at the public works in Kanduyi. The table below summarizes the activities under recurrent and development in the financial year 2020/21.

Members this table is in your gadgets, you may go through it. With your indulgence Speaker, I beg that I do not go through these tables because they are with the members. We may move to general observations.

## COMMITTEE OBSERVATIONS

1. The department had updated its Housing inventory; an activity which was done in all the quarters of the Financial year.
2. The department had formulated the Housing Bill which is awaiting Public participation after the first supplementary budget is approved by the County Assembly. That the department indeed called for a consultative meeting with the committee on formulation of the Housing Bill
3. The committee had carried out a fact finding mission on the activities under recurrent and confirmed that the minor repairs had been done.
4. That the department had renovated the houses at referral hospital and upper Milimani. This was confirmed during the committee's fact finding mission.

## IMPLEMENTATION STATUS OF ANNUAL WORKPLAN FOR FY 2021/2022

Mr. Speaker Sir, the activities under the department of Housing in the financial year 2021/2022 include the following:

- Renovation of (16) sixteen houses under major repairs; Five(5) in Kimaeti Health Center, Two(2) at Malakisi health center, Three(3) at Tamlega dispensary in Sirisia, Six(6) houses at Kanduyi under Public Works and ten(10) houses under minor repairs in Kanduyi.
- Building build a perimeter wall at Public Works estate

The summary of the projects undertaken for the financial year 2021/2022 are as follows;

Members, we also have the tables indicating the activities as were carried out during that financial year of 2021/22 and the table extends to page 11. As such, I beg to read the observations from the committee.

Mr. Speaker Sir, the committee observes as follows;

1. That all the programmes for this financial year have been awarded and the contractors are already on site.
2. That the department had a grant under KISIP programme of Kshs. 50,000,000 for slum upgrading in Mandizini Bungoma and Land Matope in Chwele. The department is awaiting the disbursement of funds for the project.
3. The committee is yet to visit the sites earmarked for departmental projects for this financial year.

## THE DIRECTORATE OF SANITATION

### IMPLEMENTATION STATUS OF ANNUAL WORKPLAN FOR FY 2020/2021

Mr. Speaker Sir, the department of Sanitation submitted the implementation status of its work plan for FY2020 / 2021 indicating the programs at different levels of implementation as shown in the table below:

Honorable members, we also have a table showing or indicating the programs at different levels. We have table one on page 12 and table two which extends to page 13. I also beg that I go through the committee's observations.

The Committee observed as follows:

1. That since the committee started to engage the directorate of sanitation in early 2021; it has managed to visit a number of infrastructural activities including the overhaul of water sewerage at Webuye staff quarters and the lower drivers' quarters in Bungoma.
2. The construction of 2 pit latrine at Milani dispensary (Bokoli ward), together with the dispensary is still in progress. The contractor had requested for part payment which is pending.
3. That renovation of Mungore Dispensary and construction of 4 No. Door pit latrines (Khasoko ward) had been awarded though the contractor had not taken off. That the department had initiated the process of terminating the contract.
4. The department of sanitation failed to conduct feasibility studies before consideration of some projects such as construction of 2 Door pit latrines at Nang'eni Market was incomplete because the proposed land was a private land and had not been paid for. The department had visited the site and there is a proposal to terminate the contract.

### IMPLEMENTATION STATUS OF ANNUAL WORK PLAN FOR FY 2021/2022

Mr. Speaker Sir, the director submitted that they targeted to do 20 projects and most of the proposed had been awarded but a few were pending at the procurement office ;These are; Pit latrine at St. Elizabeth Lunao Sec School (Bumula Ward), erection and completion of pit latrin at Musiya ECDE (Bumula Ward), construction of toilet at Katumi Primary (Ndivisi Ward), construction of ablution block /pit latrine at Lubundaa and Mundaa (Khasoko Ward), and construction of 2 door pit latrine at Matumbufu Primary School(Bukembe West Ward).

The table below shows a list and implementation status of the programmes for FY 2021/22

Members, may you go through the table on page 14 extending to page 15 and 16.

## COMMITTEE OBSERVATIONS

The committee noted the following;

1. Most projects have not been undertaken and being an electioneering year, most of the projects might not be completed.
2. That most of the projects proposed are Ward based projects but a few from the ministry headquarters.
3. There is need to move away from construction of pit latrines to abolution blocks which are cost effective and sustainable

## 3.2 COMMITTEE RECOMMENDATIONS

Mr. Speaker sir, the committee therefore recommends as follows;

1. THAT the directorate of Sanitation should be carrying out enough feasibility studies to ascertain the true status of the project sites to avoid delays in implementation as was the case at Nang'eni market where the project stalled due to the land issues.
2. THAT the directorate of Sanitation should put enough measures in place to ensure that contractors are on site and fast track the procurement processes and absorb the funds allocated for various projects and to avoid pending bills.
3. The Directorate of Sanitation should desist from implementing projects in Secondary schools which is a jurisdiction outside the mandate of County Governments.
4. The department should consider construction of abolution blocks which are cost effective and sustainable as opposed to pit latrines.
5. The chief officer for Health and that of Housing need to harmonize their work plans to be implemented under one department.
