CHAPTER TWO

ADHERENCE OF THE FY 2021/2022 FIRST SUPPLEMENTARY BUDGET TO THE PREVAILING LEGISLATION

Mr. Speaker Sir, this is the first supplementary budget for the financial year 2021/2022 as submitted to the County Assembly for review, scrutiny and recommendations to pave way for enactment of the First Supplementary Appropriation Act for FY 2021/2022.

2.1 ANALYSIS OF THE 1ST SUPPLEMENTARY BUDGET F/Y 2021/2022

The first supplementary budget was submitted and received in the office of the Clerk on 16th December, 2021 for onward submission to office of the Hon. Speaker for tabling on the floor of the house. The first supplementary budget was occasioned by a number of reasons as follows;

a) Re-voting and re-appropriation of balances Kshs. 1, 288,205,082 including conditional grants, from the previous financial year 2020/21.

- b) Compliance with the approved CARA,2021
- c) Revision of the approved projections in Local Revenue and the Appropriation In Aid.
 - An increase in local revenue (Finance Act) projection by Kshs. 246,811, 602.
 - An increase of Appropriation In Aid in the department of health Kshs. 150,000,000
- d) Regularization of the re-allocations done on specific budget lines.
- e) Declaration of Pending Bills, and allocation of funds for payment
- f) Retention fees of Kshs. 8,769, 449.

REVENUE

The first supplementary budget has seen the total county budget revenue increased from Kshs. 12,760,578,251 as approved in the annual Budget to Ksh. 14,454, 364, 384. The increase was occasioned by the Budgeting of the balances brought forward and the unremitted grants as contained in the approved KARRA of 2021. We can see the table that shows the summary of the resource envelope.

The carry forward balances were less due to the May and June Salaries that was totaling to 400 million which affected a number of ongoing programmes/projects. The CEC Finance submitted approval document from the Controller of Budget Office that allowed funds to be spent against the appropriations.

WARD BASED PROJECTS

Mr. Speaker, The ward based projects allocation remained unchanged as approved in the Annual budget.

The pending bills relating to ward based projects stood at Kshs. 592 million as per the submission from the Special coordinating units of the Ward based projects. The analysis as per the department shows most of the pending bills relating to WBP were not catered for in this supplementary budget. The figures have been captured in the respective departments.

PENDING BILLS

The pending bills totaling to Kshs. 598,033,859 captured in each department is as illustrated below. The amount does not include outstanding commitments under the ward based projects

Mr. Deputy Speaker: Just a moment Hon. Sospeter.

Hon. Bethwell Mwambu: Thank you so much for allowing me to stand on Standing Order number 49. I wish to reiterate what you spoke to this House early in the Morning before we ended our morning session. You were very categorical that the document was supposed to be sending in good time for in-depth reading and understanding, and to inform debate thereto.

I want to inform you that your directives were not followed. This document has been send to the gadgets of Honourable Members as late as almost 2:00 p.m. To be particular it was 1:30 p.m. We are talking of the document which is full of figures. This is not any common debate. This is a budget. How I wish that the Members could be allowed to read, understand the content of the document so that when the chair is reading, we can be able to move together and therefore the debate may take little time because we will have understood.

It is my prayer to you that understanding the kind of dynamics we are living in and the kind of Government we are serving, and the interests of the people we have at heart, I would like to ask that you invoke Standing Order number 49 so that the reading may stop where ever the Chair has gotten, to the resume tomorrow just to allow us to read. I know you have the passion to read and that is why you were telling us in the morning that let the document be send to Honourable Members early enough.

We don't debate from anywhere. We debate from the content of the document and you will realize that while it has come late, when it is going to be read you will know why it is important for Honourable Members to read it. So if you can bear that prayer of mine under Standing Order

number 49 (b), I will be able to ask that I am seconded by one youngest legislator we are training in the House, Hon. Luke Opwora.

Hon. Luke Opwora: Thank you. We are in a learning process. Budget making process is very key and I want to second my senior Hon. Bethwell Mwambu.

(Applause)

Mr. Deputy Speaker: Honourable Members. A Motion having been moved under Standing Order number 49 b and seconded, I propose that debate be adjourned for the reasons advanced. I propose.
