#### 1.0 INTRODUCTION

This is the Report that covers the Affairs of the Third County Assembly covering the FIRST Session and drawing together into a single, comprehensive document an account of the activities of the House in 2022.

The 3<sup>rd</sup> County Assembly of Bungoma held its 1<sup>St</sup> Sitting on Wednesday 21<sup>st</sup> September,2022 at 9:00 a.m. in the County Assembly Chambers vide Gazette notice **Number 11004** dated 14<sup>th</sup> September, 2022. This was occasioned by the general election held on 8<sup>th</sup> August, 2022. In the year under consideration, the House continued to play an important part in legislation, oversight and representation of the people, working with a wide group of stakeholders, and ensuring the participation of the people in parliamentary processes.

The report covers the following thematic areas; Calendar of the House, Special sittings of the County Assembly, Composition of the House, Training workshops for Members and Committees, Address by H.E. the Governor and County assembly proceedings and businesses which include; Communications from the chair, Papers laid, Petitions, County assembly statements, Motions, Legislative proposals and bills, Sessional papers /policies and vetting of nominees to various public offices.

# 1.1 HOUSE CALENDAR AND SITTINGS OF THE FIRST SESSION OF THE THIRD COUNTY ASSEMBLY

The First Session of the 3<sup>rd</sup> County Assembly commenced on 21<sup>st</sup> September, 2022 on the 1<sup>st</sup> sitting of the House after general election for swearing in of the elected and nominated Members of the County Assembly. Through a special sitting on 18<sup>th</sup>October, 2022 the Governor Opened the Third County Assembly officially, paving way for the Assembly to run its affairs as per the constitution and law.

The House approved the Calendar of the County Assembly (Regular Sessions) for the First Session (2022) on 25<sup>th</sup> October, 2022 pursuant to the provisions of Standing Order 31.

During the session, the House Calendar was altered twice as follows;

- a) On Wednesday 2<sup>nd</sup> November, 2022 during 2:30pm session, the House resolved to adjourn to 8<sup>th</sup> November, 2022 to pave way for the recruitment and interviews of the Clerk by the County Assembly Service Board, which took place on 3<sup>rd</sup> November, 2022 as from 9:00am in the Plenary.
- b) On Wednesday 30<sup>th</sup> November, 2022 at the 9:30am session, the House adjourned to sine die instead of it adjourning on 2<sup>nd</sup> December, 2022.

By the end of the First Session, the County Assembly had held a total of thirty four (34) Sittings of which the Regular Sittings were twenty six (26) and eight (8) Special Sittings

#### 1.2 SPECIAL SITTINGS OF THE COUNTY ASSEMBLY

The House held Seven Special Sittings during the Session, in the listed businesses below were transacted by the House;-

- 1. On 18<sup>th</sup>October, 2022 the Governor Opened the third County Assembly officially
- 2. On Wednesday 28<sup>th</sup> September, 2022 at 9:30am, Hon. Allan Nyongesa took Oath of Office and the Speaker communicated the House Leadership.
- 3. On Wednesday 28<sup>th</sup> September, 2022 at 2:30pm, a list of nomination of Members to serve in the House Business Committee, Selection Committee and Appointment Committee were tabled and there after a procedural motion to approve the membership of the three committees.

- 4. On 13<sup>th</sup> December, 2022 at 9:30am; a report by Budget and Appropriations Committee on the 1<sup>st</sup> Supplementary Budget Estimates FY 2022/2023 was tabled and notice of motion on the same report issued.
- 5. On 13<sup>th</sup> December, 2022 at 2:30pm; there was a motion to adopt the report by Budget and Appropriations Committee on the First Supplementary Budget Estimates FY 2022/2023.
- 6. On 14<sup>th</sup> December, 2022 at 9:30am; the Bungoma County First Supplementary Appropriation Bill, 2022 was read for the second time followed by Committee of the Whole House on the Bill.
- 7. On 14<sup>th</sup>December, 2022 at 2:30pm; the Bungoma County First Supplementary Appropriation Bill, 2022 was read for the third time.
- 8. On 2<sup>nd</sup> February, 2023 at 2:30p.m; consideration of the First Reading of the Finance Bill, 2022, the Bungoma County Annual Development Plan FY 2022/2023, the Bungoma County Integrated Development Plan 2022-2027 and the report by Budget and Appropriations Committee on the County Review and Outlook Paper.

#### 1.3 COMPOSITION OF THE HOUSE

Following the Administration of Oath to all Members in 2022, the entire 3rd County Assembly has a composition of 62 honorable members; forty five (45) elected and seventeen (17) nominated representing different constituents pursuant to the provisions of Political Parties Act. A few basic statistics were evident in regard to the number of returning Members, percentage of female Members, and a breakdown of Members by parties represented in the House.

In brief, an analysis of the membership of the County Assembly reveals the following:

- a) Returning Members (27 in total)-
  - (i) Elected in Ward = 25

- (ii) Nominated = 2
- b) Percentage of First-Time Vs Returning Members-
- (i) Returning MCAs = 27 (41.9%)
- (ii) New MCAs = 35 (58.1%)
- c) Breakdown of Male and Female Members-
- (i) Female MCAs = 21 (33.9%)
- (ii) Male MCAs = 41 (66.1%)
- d) Breakdown of Members by number of terms served-
- (i) 3 terms = 6 (9.7%)
- (ii) 2 terms = 21 (33.9%)
- (iii) 1 term = 35 (56.5%)

# 1.4 TRAINING WORKSHOPS FOR MEMBERS AND COMMITTEES

Capacity building is an important element as far as effective functioning of the County Assembly is concerned. During the session MCAs were trained on various aspects During the First Session, two trainings workshops were organized for Members to share information, knowledge and skills of conducting, transacting and managing business of the House and committees as well as their diverse mandates as defined in the Constitution.

During the two (2) inductions the Members of the County Assembly which were held in Nakuru and Kisumu on diverse dates, they were trained and had a privilege of interacting with various guests including H.E Governor of the Bungoma County, H.E the Deputy Governor of Bungoma County and the Chairperson of EACC among others. The Facilitators were drawn from the Kenya School of Government, the National Assembly, the Senate, Controller of Budget Office, office of the County Attorney and the internal resource persons from the County Assembly Staff.

The training covered the following topics; Etiquette, dress code and grooming, Principles of Governance in the Public Service, General role and working of the County Assembly, Composition and the role of leadership, Leadership and integrity, Sources of revenue and revenue sharing, Legislative drafting and Law-making process, The Committee system, Budget making and tracking process, How to conduct summons and fact finding, Good governance and rule of Law and Financial hygiene.

# 1.5 ADDRESS BY H.E. THE GOVERNOR

Provisions of *Standing Order 25 (1)* requires the Governor to address the opening of each newly elected County Assembly.

On 18<sup>th</sup> October, 2022, H.E. the Governor, Hon. Kenneth Lusaka, EGH, delivered an address to the County Assembly Sitting of the House presided by the Speaker. During the Session under review, the Governor made one visit to County Assembly.

#### 1.6 VISITING INSTITUTIONS

A total number of seven (7) institutions visited the County Assembly during its FIRST Session and followed proceedings from the Chamber Galleries. These included the following:-

# 2.0 COUNTY ASSEMBLY PROCEEDINGS AND BUSINESS

# 2.1 COMMUNICATIONS FROM THE CHAIR

The Speaker guides the House through a variety of avenues including communications. During 1<sup>st</sup> session, the Speaker conveyed seventeen (17) communications on various subject matters which included; invitations, political and coalition issues, plenary business and Committee matters, Honorable members' welfare, acknowledgement of the visitors in galleries, procedural issues arising in the House among others.

#### 2.2 PAPERS LAID

Documents and reports from Committees and other government bodies are normally tabled in the House. In the 1<sup>st</sup> session, twenty-four (24) Papers were tabled out of which seven (7) were from Committees, 14 from the Office of the Auditor General and three (3) from various departments in the County Executive. All the papers were committed to various committees for processing and reporting back to the House.

#### 2.3 PETITIONS

Article 119 of the Constitution accords every person a right to petition the County Assembly on any matter within its authority including seeking enacting, amending or even repealing of legislation.

During the period under review **Two (02)** Petitions were presented and referred to the Committee on Justice, Cohesion and Legal Affairs for consideration. Out of the Two Petitions referred they were still under committee consideration.

#### 2.4 STATEMENTS AND QUESTIONS

These are means through which Members of the County Assembly bring an important matter to the attention of the House, by giving notice and a signed copy of proposed question to the Clerk for submission to the speaker for approval. Members of the County Assembly may make general statements of topical concern on the floor of the House.

A member may request for a statement from the committee chairperson relating to matters under the mandate of the Committee or ask a question to the County Executive Committee Member responsible for the matter, then the County Executive Committee Member shall provide physical and electronic copies of the reply to a question at least a day before appearing before a Committee.

In the first session of the third County Assembly, a total of five statements were sought in the House and were as follows:

- i. A Statement sought by Hon. Jack Wambulwa on Implementation of CEF road projects to chairperson Roads, Transport, Infrastructure and Public Works on 17<sup>th</sup> November 2022 whose response was to be availed on 1<sup>st</sup> December 2022
- ii. A Statement sought by Hon. Alfred Wekesa on Environmental and health menace experienced by residents of Ndivisi Ward living close to Makemo dam, to the chairperson, Tourism on 17<sup>th</sup> November 2022 whose response was to be availed on 1<sup>st</sup> December 2022
- iii. A Statement sought by Hon. Jack Wambulwa on Information on the Tabala Kimwanga and Nakhwana Kimaeti roads in Kimaeti Ward under the Roads Maintenance Levy Fund, to the chairperson, Roads, Transport, Infrastructure and Public Works on 22<sup>nd</sup> November 2022, whose response was to be availed on 28<sup>th</sup> February 2023

- iv. A Statement sought by Hon. Miliah Masungo on Health service in relation to a number of Health projects under Community Empowerment Fund which have stalled in Misikhu. It was referred to the chairperson, Health Committee on 16<sup>th</sup> November 2022, whose response was to be availed on 30<sup>th</sup> November 2022
- v. A statement sought by Hon. John Wanyama on Muyayi Vocational Training Centre to the chairperson, Education and Vocational Training on 24<sup>th</sup> November 2022, whose response was to be availed on 15<sup>th</sup> February 2023.

By the end of the session all statements sought in first session of the Third County Assembly were not responded to.

#### 2.5 MOTIONS

In the First Session, the House considered 13 motions that included;

- a) Six (6) on adoption of Committee Reports on consideration of various business referred to them
- b) One motion from the County Assembly Service Board on the consideration and approval of the Clerk of the County Assembly
- c) One motion on the Governor's address that had four allotted days,
- d) One Special Motion involving approving nominees for appointment to public offices; (CECM)
- e) One procedural motion and
- f) Four (4) motions that were moved without notice.

#### 2.6 LEGISLATIVE PROPOSALS AND BILLS

During the First Session, a total of five (5) legislative proposals were introduced. Of these five (5) Bills, two were considered and approved by the House successfully as follows;

- a) The Bungoma County Climate Change Bill, 2022 (Now an Act)
- b) The Bungoma County First Supplementary Appropriation Bill, 2022 (Now an Act)

While the three (3) were still under various Committees' considerations.

- a) The Bungoma County State of the County Address Bill, 2022
- b) The Bungoma County Cultural Heritage Bill, 2022
- c) The Bungoma County Equitable Development Bill, 2022

### 2.7 SESSIONAL PAPERS / POLICIES

During the First Session the County Assembly neither received a Regulation nor Policy for consideration.

# 2.8 VETTING OF NOMINEES TO VARIOUS PUBLIC OFFICES

The County Assembly exercised its oversight role as mandated by the supreme law of the land and by various pieces of statute by undertaking vetting of various nominees to public offices forwarded to the House by the Appointing Authority. During the period under review, 11 nominees to public offices were approved by the House.

Overall, the County Assembly vetted and approved a total of **TEN (10)** nominees for appointment to the Position of County Executive Committee Members (CECMs) and approved the appointment of the Clerk of the County Assembly of Bungoma.

# 3.0 GENERATION OF BUSINESS IN THE PLENARY

Business in the Plenary / House of a County Assembly usually originates from the following areas: The Members of the County Assembly, Committees, procedural matters from the Standing Orders, Executive and government agencies such as the Independent Offices, County Assemblies Forum, the public and political leadership.

During the period under review, five (5) committees generated business for the plenary, they include: Appointments, House Business, Selection, Liaison and Budget and Appropriations. The Committee that featured during this period was **Appointments**. Members of the County Assembly originated eight (8) businesses on the floor of the House ranging from statement to legislative proposal.

Other businesses equally originated from the County Executive, Political leadership formation, other government agencies (IEBC, OAG and CAF), the public in regard to petitions, the County Assembly Service Board and own self executed procedures.

#### COMMITTEE GENERAL OBSERVATIONS

- 1. All the Papers laid and committed to various Committees of the County Assembly were not considered and reported back.
- 2. The two petitions filed in the First Session in petitioning the County Assembly on various matters is an indication of the enlightened society.
- 3. There were no responses provided from the statements sought by the Hon. Members.
- 4. The consideration of the two legislative proposals in the first session is an indication of the County Assembly's commitment towards its legislative role.
- 5. There were legislative proposals and papers committed to various committees that have not been reported by the close of the first session.

#### COMMITTEE GENERAL RECOMMENDATIONS

- 1. The Liaison Committee should provide a clear follow-up schedule for reporting Committee business after retreats to facilitate the plenary business; and enhance workability and accountability in the Committees.
- 2. The sector committees should strive to boost their oversight roles by making follow-ups on statements raised in the Plenary and any other matter incidental thereto pursuant to Standing Order 54.
- 3. Businesses pending before Committees shall be prioritized immediately the County Assembly resumes for the Second session.
- 4. Members of the County Assembly are urged to be proactive in the generation of business namely, motions, statements and other legislative proposals for consideration by the Plenary
