PRAYER

COMMUNICATION FROM THE CHAIR

Honourable members, I have some two communications to make;

One is on the state of the County address by the Governor. We have in our office the letter from the Governor with intent to address the County Assembly which reads; *I hereby write to notify you of my intention to address the County Assembly on 21st February, 2023 from 2:00 p.m. on the status of Bungoma County. This is to request your office for scheduling. Looking forward to your timely response and positive consideration. This is from Hon. Ken Makelo Lusaka.*

Therefore, Honourable members, be informed that 21^{st} February this month 2:00 p.m. the Governor will be addressing this House.

The second communication concerns the Committee on Finance. The office is in receipt of the letter from the Chairperson, the Committee on Finance, on behalf of the committee for withdrawal of Bungoma County equitable development Bill 2022. In the letter, the Chair avers that the Committee conducted a public hearing and also received views of the County Executive Committee Member for Finance and Economic Planning which highlighted grey areas in the Bill as captured here below, that require extensive architecture in its contents; that the bill:

- 1. Lacked clarity on the operations of the ward accounts.
- 2. The proposed bill does not recognise the role of County Treasury in its implementation and budgeting.
- 3. Financial management is not clear in terms of record operation to reporting.
- 4. The establishment of Board and Ward Development Committee as cited for in the Bill as a body corporate contradicts the entire Bill in terms of reporting because a body corporate does not provide the roles and relation between the CEO and the Chief Officers as well as the CECM on their respective roles.

In view of the above, the CECM - Finance and Economic Planning being the implementing entity, the Committee was in agreement with the executive that the Bill be withdrawn from

the House to consider the issues highlighted above and if need be re-introduced as per the Standing Order 153 (3).
