(Mr. Speaker [Hon. Emmanuel Situma] in the Chair)

PRAYER

COMMUNICATION FROM THE CHAIR

Honourable Members I have two communications to make.

I wish to welcome you back to the August House following the long recess and I hope that you have ably rested and are ready for the commencement of the Second Session of the Third County Assembly which will be very busy for us. Today marks the beginning of one of the busiest schedules of the session, among them being the budget process, various legislations in the County Assembly's Calendar among other upcoming crucial businesses. As we commence the session, I wish to bring to the attention of the House, that going by our practice, any Standing Order and business that was not concluded at the end of the last session, such as Motions, as well as Questions and Statements; which had not been responded to have now lapsed. To this end, every Chairperson of Committees or individual Member who wishes to reintroduce such businesses is advised to do so by contacting the Office of the Clerk to revive the business. This however, does not apply to the Bills and Petitions.

Honourable Members, with regard to Questions and Statements, I wish to direct that going forward, all the Chairpersons of Sectorial Committees to provide progress reports to the House pursuant to the requirements on Standing Order No.54. The respective reports should indicate the list of Questions and Statements referred to their Committees, those awaiting further information or a reply and those still pending. The chairpersons will be expected to avail this information in form of a brief statement to be made in the House. These reports will enable Members to know the fate of their Questions and Statements which were still pending.

The second communication provides guidelines for the management and operations of Committees. Honourable Members, in the recent past, there has been concern on the manner in which Committees are being managed and particularly by the Chairpersons and the Honourable Members. It is on the basis of these concerns that I am issuing this communication to address the critical issues that affect the management and operations of the Committees; the importance of Committees cannot be gainsaid as alluded during the Leadership meeting and in the Liaison committee's retreats in Kisumu. Committees serve as

the reference point for legislation, oversight and involvement in the public affairs of the legislature in a manner contemplated under the Constitution. It is the manner in which the committees conduct their business that builds up or destroys the image of the legislature.

First, the management of the committees as you are aware is vested in the Office of the Speaker, the Liaison Committee as per Standing Order No. 216 (2), and the Chairpersons of the committees as per Standing Order No. 182 and Office of the Clerk. The four offices working in synergy enable the operations of the committees to run efficiently and effectively, thereby ensuring that the House executes its legislative and oversight mandate as provided for under the Constitution and the County Assembly Standing Orders.

Honourable Members while the Speaker, the Liaison Committee and the Chairpersons of the Committees offer strategic leadership and directions, the Office of the Clerk is facilitative in nature and has however, over the years come to be regarded as the backbone of the committee system in all parliamentary democracies. In our day to day operations, committees are managed by Committee Clerks and other officers who give procedural advice to the Committee, take minutes of Committee proceedings, receive and preserve documents on behalf of the committees and carry out other important logistical and administrative duties. The Secretariat also assists in official communication, arranging appearances of witnesses and advising the Chairpersons and Members on the procedures in committees. In essence, the Committee Secretariat is responsible for coordinating the affairs of the Committee in ensuring that Committees get the needed support to be effective in discharging their mandate.

The effectiveness of any oversight committee has therefore a bearing of the services provided by the Committee Secretariat and the synergy between the Secretariat and the Chairperson of the Committee. I urge all Chairpersons to accord the Secretariat the necessary support in the discharge of their duties and more importantly in the application of the Standing Orders and unwritten practices of the House.

Secondly, on the conduct of the meetings, Honourable Members, in the recent past there has been a worrying trend in the frequency at which Committee Members are holding meetings to the exclusion of the Secretariat; and more so the Committee Clerks. Committee Clerks are officers of the House and just as the case with the House which cannot sit without the Clerks at the table; Committees should not meet or transact any business without the Secretariat.

A committee meeting is therefore not complete in the absence of a Committee Clerk and the Secretariat and will henceforth be treated as an informal gathering or a committee's *kamukunji*. Committees are allowed within their powers to exclude any person or even the public from its proceedings for justifiable reasons, pursuant to Standing Order No.250, but such exclusion however, does not apply to Committee Clerks who are a part and parcel of the committee architecture.

Third, on attendance of committee meetings; Honourable Members, the attendance of committee sittings by Members is important for effective oversight. It has been brought to my attention and witnessed in person that some committees are finding it extremely difficult to raise quorum within the requisite time as provided for in Standing Order No. 187, which states as follows;

'Unless quorum is achieved within 30 minutes of the appointed time, a meeting of the Committee of the House shall stand adjourned to such a further time or a day as the Chairperson of the Committee may appoint'.

It has been difficult when the Chair comes late to a meeting and finds that Members have already left. Committees are unable to sustain a quorum during deliberations or businesses before them. Members just appear for the sake of recording attendance and disappear into thin air. This has brought embarrassment and loss of dignity to Committees and the County Assembly as a whole; especially when witnesses have been invited and the meetings do not take off or end up with one or two Members only conducting the business of the Committee. This is a shame and must come to an end.

Further, there have been instances when committees fail to raise a requisite numbers necessary for adoption of reports, thus, draft reports remain pending before Committees for unnecessarily long periods. I implore Members to fully participate in committee sittings, to enrich their deliberations and be seized of the matters under consideration; to enable committees come up with impeccable findings and recommendations. Let us all ensure that retreats and field visits are properly utilized to conduct businesses and not as grounds for picnics and holidays. There must be value for money on any committee activity. I therefore direct as follows;

- (a) All Chairpersons or persons designated to chair committee meetings or committee retreats pursuant to Standing Order No.190 shall close the attendance register upon the close of the business, and no Member shall be allowed to sign the register or Committee's report whose contents they are not aware of.
- (b) Adoption of the Committee Reports shall be done at the venue of the retreat, upon conclusion and adoption of the Committee recommendations. No more signing of committee reports in our committee rooms.
- (c) Members should and must attend committee meetings without fail. If they fail, the provisions of Standing Order No.189 will apply; where failure to attend four (4) consecutive meetings without the permission of the Chairperson or the Speaker will lead to **automatic removal** of that Member from that committee. Any Member discharged from a committee in a situation such as this for non-attendance will not be eligible for re-appointment to any other Committee. We won't transfer your problems to another committee.

I urge Chairpersons of committees to co-operate with the Committee Clerks to provide lists of attendance on every committee sitting for purposes of administering Standing Order No.189.

As agreed in the Leadership Retreat recently in Kisumu, I hereby direct that the provisions of these Standing Orders and recording of sittings of committees and particularly on quorum be implemented to the latter. We need to remind ourselves that those who desire not to attend or be Members of committees can as well indicate such desires to their respective leadership of the political parties.

Fourth, on Committee reports Honourable Members, committees communicate to the House through their reports. It is, therefore, imperative that committees prioritize consideration of Bills, Sessional Papers, statutory instruments, audit reports and Petitions and submit reports within the statutory timelines. Some committees have taken inordinately long to conclude inquiries, engaging in unending investigations while others re-open inquiries even after going for report writing. The delay in concluding inquiries and producing reports on time leads to unnecessary speculation and fuels rumours of rent-seeking, among others. This waste of public resources on unending "investigations" will not be accepted.

Finally, Honourable Members, this being a House of procedure and rules, I, therefore, urge you Members to conduct your official business within the provisions of the Constitution, statutes and our own Standing Orders and, particularly, respect the rules against anticipating debates and commenting on reports which have not been tabled before the House for consideration whether in a funeral or in a wedding or any other venue or before this House.

I urge committees to take legislation and other business before them more seriously and report within the stipulated time frames. The House is accordingly guided for implementation of this communication by the Chairs, Vice Chairs and Members whose mandate was given to them by the Selection Committee. Thank you.

Hon. Speaker, allow me call upon the Leader of Minority to second.

Hon. Anthony Lusenaka (*Leader of Minority*): Thank you Speaker. I rise to second the motion. As you realize, we started a new session and without this Committee there would be no business. This is the engine of this Assembly and I would like to ask Members to pass the motion as it is. Hon. Speaker, arising from your communication, you may realize that from the minority side in this Committee of 11 we are only three...

Mr. Speaker: Hon. Lusenaka, you have just one command; you second. The other business you can engage us as we are debating, but for now, stick to seconding.

Hon. Anthony Lusenaka (*Leader of Minority*): But it is part of seconding Hon. Speaker. Allow me to finish. In a committee of 15 we are 4, so I think the government is failing and arising from this communication and this motion, I want to request the majority to whip the Members from the Kenya Kwanza coalition. They should be serious, because all the Chairs and Vice Chairs come from the Kenya Kwanza side...

If this Assembly fails, it is the government failing. Hon. Speaker my request is that they have the mandate; we chose them as the Chairs and Vice Chairs of various Committees. For us, we are ready to work, but we are a coalition and minority side therefore we can't do much. If given an opportunity to replace those Members who are not serious, we will take up the challenge. I second Mr. Speaker.

Mr. Speaker: Honourable Members, before I propose a motion for this House to consider, as you are going to debate, beware of Standing Order No. 177 (2) so that you are aware of the consequences of your debate.

Honourable Members, a procedural motion has been moved pursuant to the provision of Standing Order No. 173 (1) (g); that the House approves the nominations of Honourable Members whose names have been laid in this House for approval to serve as Members of the House Business Committee for the Second Session or the Third County Assembly, I propose;

Hon. James Mukhongo: Thank you Mr. Speaker. I rise to support the motion that the names that have been laid before this House to serve on the House Business Committee be approved. When we came in as a new Assembly, we constituted committees basing on the strength of the coalitions. After going through the names, I have not seen any interference from either my coalition where I am a Member from the Kenya Kwanza coalition; we have been given our rightful share and that goes for the minority side as well. Hon. Speaker, it will be sad because you have given us the mandate to close the attendance register at the end of every meeting; and which will be done. I am promising that as the Chairperson of the Finance Committee, I will do so because I know my Members from Kenya Kwanza always keep time. I am urging even the opposition side to also keep time and I know they always keep time; because there are no late comers in my committee.

Otherwise, as we move forward, you have also told us to participate in retreats. Yes, we need to participate, but you as our Chairperson of the Service Board you also need to do the necessary for us, so that our pockets are filled. If my pocket is good, then I will attend. Sometimes I might be forced not to attend because of my pocket. Therefore it also lies in your hands, as the Chairperson of the Service Board. I know the composition of the Service Board, where my brother Hon. Balala is a member; I know him at one time, we know he requested this House to give us a Christmas token, which we ended up being surcharged for. It should not be like that my brother; we want to do things procedurally and according to the law. Otherwise, I support the motion Hon. Speaker.

Hon. Milliah Masungo: Thank you, Mr. Speaker Sir. First and foremost, I want to say that Happy New Year to everybody because all of us went for Christmas and we are back again. We thank God we have actually added weight, if you look around, these are not the people. We have had all our time, enjoyed with electorates, we thank God for everything. I want to support the motion and I am sure that the Members have confidence in the safety of the names on the floor. That it has been our duty that we fully be punctual in our meetings, just to expedite the running of the Assembly. I support the motion.

Honourable Members, it is our cardinal duty to see that legislation in this House is done at the best of our energy and level. From your communication Speaker, I feel that we should oblige with your segments and now that we are here as representatives of the people, we need to maintain what is our rightful duty as Honourable Members. All committees that generate business for this House and if we miss to attend those committees, we have to be sure that there will be no business in the House and at the end of the day, our representation of our people would have failed. Thank you Speaker, I support the motion.

Mr. Speaker: Honourable Members I want to limit debate on the list of Members with the following guidance; when we approve the list of Members, the House will be suspended for 20 minutes. We will suspend the sitting to convene the HBC in my chamber; to come up with the Calendar of the Assembly sittings from tomorrow, and then come back for a continuation of the sitting to approve the Calendar and the Order Paper to run from tomorrow till Thursday. Therefore, I will suspend the sitting, walk out, have HBC and come back for a continuation. I am limiting debate so that we allow the new HBC that we are going to approve to go and approve the calendar, because it is the new HBC that is supposed to approve the calendar running from today afternoon.

Are we together Members?

Therefore, allow me call the mover of the motion to respond.

Hon. Joseph Nyogesa (*Leader of Majority*): Thank you Speaker. I concur with colleagues as they support the list. It is just a matter of improving and doing the needful as Hon. Milliah has said. It is our responsibility also as leaders in our coalitions to ensure that Members are attending meetings. You know Speaker, it is so challenging and that it is too early for Members to get relaxed. Members, you know, there is no way we can hide. I agree 100% with Hon. Lusenaka because in a committee of 15 Members or 11 Members, there is no way we can say that there is no quorum yet Members of the ruling coalition are more than enough. Members kindly, let us up our game. I know we talked and we only need to actualize. Hon. Speaker, you will realize that in the on-going interrogations, the attendance is too low. We need to be serious and do the necessary. Otherwise, thank you for supporting the list.

Mr. Speaker: Hon. Joseph Nyongesa now you can proceed.

Hon. Joseph Nyongesa (*Leader of Majority*): Thank you Hon. Speaker. Allow me move the Procedural Motion on approval of the Legislative Calendar for the Second Session of the Third County Assembly 2023. Pursuant to the provision of Standing Order 31(1) this House

approves the County Assembly Legislative Calendar for the Second Session of the Third Assembly 2023. Those are regular sessions of the County Assembly for the year 2023 from February to December, 2023.

We have our schedule shown on the table and I hope members have now received it and they are moving with me. This regular session shall be operated as follows;

The second session shall start on Tuesday 14th February to 7th December, 2023 with three sitting days; this will be from Tuesday 14th February to 16th March, 2023. The days to be sat will be Tuesdays afternoons, Wednesday mornings and afternoons and Thursday afternoons only. We shall have a short recess from Friday 17th March to Monday 27th March, 2023.

Part Two

Our sitting days will be from Tuesday 28th March to Thursday 4th May, 2023. Days to be allocated will be on Tuesday afternoons, Wednesday mornings and afternoons and lastly Thursday afternoons.

We shall have a long recess which shall start from Friday 5th May to Monday to 5th June, 2023.

Part Three

Our sitting shall be as follows; we shall start from Tuesday 6th June to Thursday 13th July, 2023. This will be on Tuesday afternoons, Wednesday mornings and afternoons and Thursday afternoons.

Hon. Antony Lusenaka (*Leader of Minority*): Thank you Hon. Speaker. I rise to second the Procedural Motion as moved by the Leader of Majority. This calendar gives us ample time to plan for the activities within the year. We have CASA games coming up, I think in April or May.
