**Hon. Jack Kawa** (*Chairperson*, *Gender Committee*): Thank you Hon. Speaker. I move that the Bill be read for the second time.

**Mr. Speaker:** Honourable Members the Bill be read for the second time.

A Bill of an Act of the County Assembly of Bungoma to promote and protect culture and cultural heritage in the County and for Connected Purpose; Second Reading

**Mr. Speaker:** Hon. Kawa, are you the one taking care of the Committee of the Whole House?

Hon. Jack Kawa (Chairperson, Gender Committee): Yes Sir.

**Mr. Speaker:** Of course what happens next is that we collapse into the Committee of the Whole House. I will vacate the chair and allow the Deputy Speaker to chair the Committee of the Whole House. We rise up; lower the mace as I vacate the chair.

(Speaker vacates his seat as the House collapses into the Committee of the Whole House to consider the above said Bill)

**Hon. Stephen Wamalwa** (*Chairperson, Committee of the Whole House*): You can be seated Honourable Members.

Hon. Kawa. Honourable Members let us be orderly. I now propose the question which is that clause 21, be part of the Bill.

**Hon. Hentry Nyongesa**: Thank you Chair. Bear with my colleagues, but I want to exclude myself that Members look like they don't have anything to refer to. They are just waiting for me that is their concern chair.

**Hon. Stephen Wamalwa** (*Chairperson, Committee of the Whole House*): Thank Hon. Nyongesa, I think you can check on your emails; it has been sent to your emails, unless your gadget has an issue or is faulty. So let us proceed.

#### Clause 3

**Hon. Jack Kawa:** Thank you Chair, I move that the Clause 3 be amended by deleting the words "regulate, protect and promote the following activities and the services of County importance for the interest and enjoyment of the community and persons visiting the county" immediately after the words "Act are" and the paragraph "a and b" be deleted and the words "cultural sites and cultural activities" be part of the paragraph so as to read;

3 (a) "the objects of the Act are to regulate protect and promote the cultural sites and the cultural activities for the interest and enjoyment of the community and persons visiting the County'

And that sub clauses from "c, d, e, f, g, h, i" be re arranged as "b, c, d, e, f, g "respectively.

**Hon. Stephen Wamalwa** (*Chairperson, Committee of the Whole House*): Thank you. I now propose the question which is that the clause three, as amended be part of the Bill. I now propose the question which is that clause 3 be amended as proposed.

The question with regard to Clause 3 as amended being part of the Bill was put and agreed to.

#### **Clause 4: Application of the Act**

**Hon. Jack Kawa:** Thank you Chair. I move that Clause 4, Sub Clause 4 (c) be approved with the amendments by inserting the words "or *Acts of Parliament* "immediately after the word "Constitution" so as to read, "vested under the national level of government by virtue of the Constitution or Acts of Parliament".

**Hon. Stephen Wamalwa** (*Chairperson, Committee of the Whole House*): Thank you, Chair. Honorable Members, I now propose the question that Clause 4, as amended be part of the Bill.

The question with regard to Clause 4 as amended being part of the Bill was put and agreed to.

#### **Clause 5: Authorized Officers**

Hon. Jack Kawa: Thank you Honorable Chair, I move that the Clause 5 be approved with the amendments by inserting the word, (a) "in consultation with the County Public Service Board" after the word "Member" and (b) and by deleting the word "County' so as to read "the Executive Committee Member in consultation with the County Public Service Board shall by notice in the gazette appoint such a number of officers with knowledge and experience in culture to be authorized Officers to oversee the activities taking in cultural sites under this Act".

**Hon. Stephen Wamalwa** (*Chairperson, Committee of the Whole House*): Thank you, Chairperson Gender now Honorable Members, I propose the question that Clause five be amended as proposed

(Question proposed)

I now put the question which is that Clause 5 be amended as proposed

The question with regard to Clause 5 as amended being part of the Bill was put and agreed to

#### Clause 6: Responsibilities of the County Government

**Hon. Jack Kawa**: Thank you Chair. On Clause 6, I move that sub clause 6 (1) (a) be approved with amendments by inserting the word "thereto" immediately after the word "individual" so as to read, "all in trust for the communities in the county and the cultural articles and cultural sites not owned by an individual thereto or organization" and that Sub

Clause one be amended by deleting the words "items of" after the word "protect" and inserting therefore the words "and promote their intellectual property relating to" so as to read, "assist community groups and individuals to protect and promote their intellectual property relating to their cultural activity or heritage" and that paragraph (a) deleted and paragraph (b) and (c) be renumbered respectively, I move chair

**Hon. Stephen Wamalwa** (*Chairperson, Committee of the Whole House*): Honorable Members, I now propose that the question which is that Clause 6 be amended as proposed. (*Question proposed*)

The question with regard to Clause 6 as amended being part of the Bill was put and agreed to.

#### **Clause 7: Protection of Individuals**

**Hon. Stephen Wamalwa** (*Chairperson, Committee of the Whole House*): I now propose that clause 7 be part of the Bill.

So as to read, "No person is compelled to perform, observe or undergo any cultural practice or rite" I move.

**Hon. Stephen Wamalwa** (*Chairperson, Committee of the Whole House*): I now propose the question which is that Clause 7 be amended as proposed.

The question with regard to Clause 7 as amended being part of the Bill was put and agreed to.

Clause 14, declaration of cultural sites

I move the amendments.

**Hon. Stephen Wamalwa** (*Chairperson Committee of the Whole House*): I now propose the question Honourable Members that Clause 14 be amended as proposed and now put the question, that Clause 14 be as proposed.

(Question put and agreed to)

Clause 17 Mission of Cultural sites

Jack Kawa:** I move that clause 17(i) of the Bill be approved by with amendments by deleting the expression (20) and substituting therefore the expression 14 so as to read; 'the departments shall determine the times, dates and the conditions under which the cultural sites may under 14 if opened to the Public,' and (v) by inserting the words 'cultural site' and a

person ordered to leave immediately after the word 'leave' So as to read; 'where a person in a cultural site commits an offense relating to this part, an authorized officer may ask that person to leave the cultural site and a person ordered to leave must leave the premises by the shortest route available to the Public'. I move.

**Hon. Stephen Wamalwa** (*Chairperson, Committee of the Whole House*): Honourable Members, I now propose the question, that Clause 17 be amended as proposed and now put the question that Clause 17 be amended as proposed.

Jack Kawa:** I move that Clause 22 of the Bill be approved with amendments by deleting the words 'Commits an offense and replacing with 'who' and introducing a new sub clause (i) so as to read, 22(i) A person who, and (ii) be amended by deleting the words 'or any other section under this part' appearing after the words under (i) so as to read; 22(ii) A person who commits an offense under (i) is liable on conviction to a fine not exceeding Ksh. 200,000 or to a term of imprisonment not exceeding 2 years or both and by deleting (iii) in its entirety. I move.
