**Mr. Speaker:** Hon. Members, allow me before I proceed allow Honourable members to make very brief remarks about our visitors in the public gallery Milo Girls from Sitikho Ward. At most four people before we proceed chair Education, Vice Chair Education you start .Member of Education Committee Yes, Hon. Obama

**Hon. Abraham Obama**: Asante Bwana Spika. Nachukua fursa hii pia kupongeza wanafunzi wetu kutoka Sitikho na kuwa karibisha hapa katika Bunge hili . **Hon. Stephen Wamalwa**: Asante Sana Mheshimiwa Spika. Najua kwamba Mheshimiwa Mukoyandali ana mambo mengi fiche ambayo hatuyajui na kuyafahamu. Hata hivyo kwa ufupi sana nachukua nafasi hii vile vile kujiunga na wenzangu kutoa arifa fupi kuwapatia wanafunzi wetu mawaidha wakati wamefika hapa Bungeni.

Hili ni Bunge la Jimbo la Bungoma na ni mfano kamili wa Bunge ambalo liko Nairobi la kitaifa. Tukiwa hapa ni kufanya kazi ambayo tumetumwa na jimbo letu la Bungoma. Ya pili ni kuweza kuangazia maswala ambayo serikali ya Bungoma inafanya na vile vile kutunga sheria . Hayo ndo

## RESPONSE TO A STATEMENT RAISED BY HON. JOSEPH NYONGESA DIRECTED TO THE CECM EDUCATION AND VOCATIONAL TRAINING

**Mr. Speaker:** You bring in the CEC if he is accompanied by the Chief Officer they both come in. Hon, Members, we will have some slight change in our procedure.

Previously, we have been asking the clerks table to read afresh the statements but unfortunately, when they are transcribing in the HANSARD, there is no space for the for the table clerks. So we will be asking the owner of the statement to read a fresh the statements, which will be captured, then allow the CEC to respond accordingly.

Members before us, we have our CEC for Education. Dr. David Wanyonyi accompanied by the Chief Officer for education. Nicholas Kiboi they have come in obedience of invitation to respond statement raised by our Leader of Majority Hon. Joseph Nyongesa.

Members, you do agree that in my communication at the commencement of siting because of the nature of the statement sought covering 45 wards. It was agreed that basically the same be answered in the opening plenary where all the members of the 45 wards can be able to get the gist of the expenditure of 3% of the vocational training, amount of money and 3% of the of the budget .

Honourable Majority because of the HANSARD recording, there is no space for the Clerks at the table so you will go through your statement afresh, then I will be able to invite our CEC to respond as per the response given to us here which members all of you are having on your gadget. So Hon. Leader of Majority you proceed and ask your statement then the CEC will have a chance to respond but now you will respond using the dispatch microphone because you cannot be sitting while responding to us. Proceed Leader of Majority

**Hon. Joseph Nyongesa:** Thank you, Speaker for your guidelines. Even before I read my statement at least the CEC could also be in a position just to share with us the status of the scholarship so that at least when we are from here this weekend we know how maybe to tackle it because as we speak they are at home. Basing on your guidelines, so I don't know I will be reading one I wait for the response before I go to two or I read the whole of it.

**Mr. Speaker**: Read the entire statement. Then I think a as we get the feedback will be saying number one answered number two, that way to the end.

**Hon. Joseph Nyongesa**: I thought maybe we could tackle number one as we go to number two **Mr. Speaker:** Is also a formula. We can have it done that way you ask he responds

Hon. Joseph Nyongesa: Thank you.

**Mr. Speaker:** Then that means, Honourable Members you are at liberty to seek clarification in the middle of the response from the CEC. You are not barred from asking or interjecting to seek clarification. Let's proceed.

**Hon. Joseph Nyongesa:** Thank you Speaker. I am here to seek a statement in relation of the utilization of the 3% of both scholarship and bursary funds. The CECM to respond on the following one provide the expenditure reports of the 3% of the scholarship and bursary funds. I think there it will be better

Mr. Speaker: CEC you proceeded to give us a feedback on item number one as sought in the statement.

**CECM Education:** Thank you Mr. Speaker. Allow me also to read again because that is how I will be guided better. Provide expenditure report of 3% of the scholarship and bursary funds. I responded as the 3% expenditure report for scholarship and bursary as at 30th June 2023 is as indicated in attached annex. The total allocated funds for the education support was 400 million, which was scaled up to 5.4 million during the supplemental budget. The 3% of the allocated amount is 15,720, 000 which was expended as follows; launching of the county Scholarship Committee 305,000.

Normally we have the scholarship committee at the county level. We have the ward level then we have the county level. So at the county level, we spent that much. Education Support Scheme board members' facilitation. We facilitated there coming of course in terms of seating allowance, meals, it cost 351,000. Allow me demonstrate thus that we are talking about the Education Support Scheme Fund. It is a fund and it runs from first of July up to 30th of June. Therefore, vetting had been done and this was prior to students remember when you had the issues of COVID these students join institutions in May or there about 2022 therefore vetting was done but we have this term reverting which we are...

**Mr. Speaker:** Kindly be very clear their 2022 May. That was the previous financial year's budget.

**CECM Education:** I am talking about vetting

Mr. Speaker: of course that the previous budget.

**CECM Education:** Mr. Speaker, the members the term re vetting I was just trying to qualify the termer re vetting. Yes. So as I qualify that term re vetting under verification of beneficiaries. So the re vetting is because we had numbers and this one, Speaker just allow me to explain a bit.

When I came to office I was sworn in November and we found the numbers were such that the amount that was allocated seemed to be less consequently we thought at the executive level what can I do? Therefore, we had to do some re vetting to reduce the numbers guided by the amount that we had.

So 4,353, 250 scholarship launch, this was in December. We spent 3,023, 500. Then we have consultative meetings with education stakeholders in Kisumu and Dicece offices to deliberate on form two beneficiaries and getting a way forward. It cost 3 million and at this level allow me explain that there are activities in the department. Our own activities we had some money and we didn't want to go beyond the 3%. So we did internal borrowing. Therefore 2, 575,621 were borrowed from the normal Departmental Budget and we have bank charges which are also a cost for the 3% 184,661.

I move on to B because...

Mr. Speaker: Yes Majority

Hon. Joseph Nyongesa: Thank you Speaker.

**Mr. Speaker**: You just leave your books there, there is no problem Because when you respond you must come back to the microphone.

**Hon. Joseph Nyongesa**: Because actually our need is maybe to get some clarity. If the CEC could tell us the membership of this committee and maybe to open up how many are they? Then to also clarify to us reverting was done by the committee at the executive level or Ward level because these ones majorly for the County level. So I don't know which re vetting are they doing instead maybe they were just verifying because re vetting was done by the committee members the ward level and putting in mind that as he came in he said and we should underline this word that there were no funds but now we can see the figures. If the committee, over the figure that he is going to tell us, could utilize 4 million on re vetting 3 million or so. May be such a thing also to be put in mind. So were benefiting the committee or the students?

**Mr. Speaker**: hope you are writing some here before you come in. Just hold on first before you come in. I am seeing some two people Hon. Mukhongo and Hon. Ken ask before I allow him please

**Hon. James Mukhongo**: Thank you Honourable speaker. We need the CEC to be smart in giving us some information because looking at the question, 3% of the fund is 15 million. Don't just give us block figures. It is better for you to say the 3 million was spent on this activity. This much was spent on this activity this much was spent on this activity for us to understand.

Mr. Speaker: Thank you what you want to ask then CEC will have time to respond

**Hon. John Kennedy:** Thank you, Mr. Speaker mine is just on the tabulation, the breakdown that the CECM has given what I have unless I missed something is about 11.1 million. So maybe he can just go through again.

**Mr. Speaker:** You CEC you now have a chance to respond.

**CECM Education:** Thank you, Mr. Speaker. First let me follow the Leader of Majority has asked about committee membership and the committee membership we have at two levels, we have the ward level and the at the county level. At the ward level, there are five at the county level, there are nine and these nine when they meet we require an X official, the CEC is an X official. So you will find that when we meet or they meet if I am present we can go up to 10 and specifically in this case at hand. We had a lot of issues to do with numbers.

So I used to have the ICT person sit in so most of the time they were 11.I think *Mhehsimiwa* has asked about re vetting. I wish to share this, re vetting was done in January 2023 and the figures I say it that when we talk about the fund. We are looking at it from first of July up to so in reporting these issues have to come together.

Hon. Mukhongo has talked about I should very specific and I want to say that...

Mr. Speaker: Yes Hon. Kikechi,

**Hon. Bernard Kikechi:** Thank you, Hon. Speaker. Mine is just maybe if *Waziri* Can clarify? At what level?

**Mr. Speaker:** who is the *Waziri* now?

**Hon. Bernard Kikechi**: Okay, they CEC honourable Speaker Can you clarify at what level was riveting done was it at the ward level or at the county level? Thank you.

**Mr. Speaker:** It's okay. We'll clarify that I am seeing Honourable Job

**Hon. Job Mukoyandali**: Sorry, Mr. Speaker. Thank you for giving me this chance. Honourable Nyongesa Our Majority Leader has raised a very good statement and I don't want to appear like I am siding with *waziri* but I am really following up. How I wish we gave him time so that he becomes our lead. He runs us through then after he finishes maybe we ask now our questions we will move. That's just my view.

**Mr. Speaker:** Thank you. Majority you are online.

**Hon. Joseph Nyongesa**: Thank you Speaker if our CEC could help us. You see, we are now dealing with a committee of nine members. So when you say vetting, re vetting and verification of beneficiaries at 4.3, then you will tell us how many days were spending these 4.3 million. That's the issue that we want

**Mr. Speaker**: CEC now. Jack you have something else? You know, we must find a way of moving. Okay, me I am prepared to sit up to 1pm the way you know I always eat breakfast and lunch, super. So let's proceed.

**Hon. Jack Wambulwa:** Thank you, Hon. Speaker. I want to request the CECM to be clear on what the majority has put to him. Actually he has made it easier for him. We are more interested in the 3% on scholarship the 15 Million. Tell us how much went to each ward. I think that's what members are interested in knowing how much went to each word and it went through who because as we talk some of us, nobody has ever received amongst our committee members. Like in my ward I will give an example; nobody ever saw the 3% of scholarship in Kimaeti Ward Thank you.

**Mr. Speaker**: Yes, CEC, you are now

**CECM Education:** Thank you. Honourable speaker I will seek your indulgence because the questions appear like they are interlocked but allow me answer what the leader of Majority raised. He talked about the nine memberships. There is another question. That's where I was your seeking your indulgence that some of them are related.

Then it has been the question of is re vetting done at the county level or at the ward level? I am using the guidance from the 2019 Bungoma Education Support Scheme regulation. A product of this House and it talks about the fund.

In this case, I want to state that the 15% I am putting together with what Hon. Jack has raised the 3% and I think its part of the equation that follows .3% how is it used? So the indulgence of the Speaker, the Honourable Members if there is 3%. 3% it is not for the ward only, it is for operations and the regulation says a total of 3% of the total amount will be used for administrative a purpose, that's the catch term Honourable members.

So when it comes to administrative purposes, it means that the use of that money begins from the CECs, office expenditure, operations and part of what I think is part of the equation that follows. Consequently, Speaker engagement of the Honourable Members, it is that as *Mheshimiwa* Jack asks how much reached the ward.

So the main issue here, back to what Leader of Majority rose is that the re vetting begins in the ward. Those are the people who do that re vetting but there must be a referee, somebody has to move from CECs office to be part of them to see what is going on and the expenditure when somebody goes there, he she has also gone on the same 3%. So *Mheshimiwa* Hon. Leader of majority it is that yes, it begins from the ward then it comes to the county level.

The position is that when you look at the regulation, it says that "and the county committee will verify" verifying It also talks about the guidance by the CEC. Verification requests this team to come and sit because it is there I am following the regulation of this House. So *Mheshimiwa* Jack that's how the county level also comes in. So it's like it's a partnership. It is not that this one's finishes and without the ward then the county cannot do anything. The county has now to get this and to finalize and that is where I get also the authority that there is a body that I sit with and now wind up.

Honourable speaker, Honourable Members, the chair of that committee and I have said an ex official is always the chief officer. So Hon. Kikechi I think it is part of the same equation was talking about, at what level does the county or the ward come in, unless otherwise I will still engage *Mheshimiwa* Kikechi for that. How much did each ward receive? Allow me repeat and I am not repeating for its sake, I am trying to stress the point that the work starts from the ward it comes to the county, the person sitting at the helm at the county is the CEC and I happen to be the one today before I leave this place.

So what happens is that we operationalize this money part of the money, *Mheshimiwa* has talked about the specifics. About how much went where and *Mheshimiwa* let me say this when the team leaves Bungoma and it will not be one, Bungoma is wide enough, they are going to Ndalu, they are going Chepyuk, they are coming to Musikoma is an expenditure and at one time, this one am very sincere. We had a lot of problems with finances.

Then I said to I have a vote to charge. Why should we stop at the county level? We can use even the fuel from this levy because they are doing the scholarship work. So *Mheshimiwa* when you look at the days these people are in the field and I have a number of documents that I will be tabling here that they were using as they go to the field from the county level. That's how the money was used. *Mheshimiwa* as I sit here today, the monies that went to the ward there was 55000 there was 33,000 ...

**Mr. Speaker:** Honourable CEC you know, I'm trying to look at your reports. You have your report? The response?

**CECM Education:** Yes

**Mr. Speaker**: You have a copy your response? The one you brought here. This was the booklet you have it.?

**CECM Education:** Yes I have it.

**Mr. Speaker:** Look at this page where your name appears . You have it?

**CECM Education:** That's page three

Mr. Speaker: It is not paginated so I don't know which page is that were your name appears

**CECM Education:** It appears on the third page?

**Mr. Speaker**: To me is on the third that is page three.

**CECM Education:** Yes, please.

**Mr. Speaker**: Is it signed by you?

**CECM Education:** I think the one am carrying is signed

**Mr. Speaker:** So the one I was given is not signed. Let's go ahead with the same report. Look at where the boards fund manager report appears. Chairperson of the board fund figured that page? Is it signed?, You are not the CEC is it signed?

**CECM Education:** I have not reached that page.

**Mr. Speaker:** After the management team the next page is the board

**CECM Education:** Honourable Speaker if you don't mind because I sit with so many people, they may have interchanged the one I signed and brought a wrong one. I am sorry for that

**Mr. Speaker:** I want you to look at this report I am referring to because it came from you before I am able to seek clarification. Be shown the one I am having then we will be able to proceed. Are they signed?

**CECM Education:** They are not signed.

**Mr. Speaker:** Even the bank statement area, is it certified? Are they certified?

**CECM Education:** Honourable Speaker, about the bank statements I think when I asked the staff they were to get it on soft, and this is in soft, there is a likelihood of that variation.

**Mr. Speaker:** You know the challenge we are having is that the way it is we cannot even take them to be very serious; it is like a love letter and nothing else in it. The seriousness of the issue at hand isn't being taken by you, because if you are the one writing a report to the Assembly and you can't sign it for us to consume then we can't take you serious.

**CECM Education:** Honourable Speaker, I sincerely apologize.

**Mr. Speaker:** We will allow you to go on so that people ask you questions, but next time as a free advice, let the officers forwarding this report sign and counter. You know what you table you are going to leave it here so you are tabling evidence before us which you are not even owning up, it is like a love letter to a girlfriend.

When you look around is like everybody wants to ask you questions so I don't know if I should let them ask you questions on what you are not able to own up or not.

**Hon. Isaiah Sudi:** Hon.Speaker, I expect the CEC to have done his homework well, we may leave here mot knowing what he has done because he is just fumbling. The question was very straightforward, like now the 9 member committee, what are their allowances per day so that we know and tabulate ourselves. As we are sited here, we know our allowances when we go out, he needs to tell us so that we know how the money was expended, and it is so easy.

For the past 30 minutes we are just on one question without an answer. We are giving him a chance but let him be straightforward that this is what we did so that we also get it right because we are following.

**Hon. Lindah Kharakha:** thank you Mr. Speaker for giving e this opportunity, I am sitting here trying to catch what exactly is going on. I wish we had a structured way of how the CEC can present issues.

First of all, I think we should allow him present his response to the question asked then after that we can ask questions here and there. At this point we are looking like we are bullying him, sorry to use that word...

**Mr. Speaker:** There is no bullying in this House, everybody is protected,

**Hon. Lindah Kharakha:** I understand, sorry for using the term but what I mean is we are looking like we are going back and forth and we are not getting the exact thing from the department. It might look like he is not hands on in the department but given a good opportunity; the Honourable CEC can be able to explain himself better so that others who are not in the committee or who are not well versed with the department have an opportunity to know what is going on.

**Mr. Speaker:** We will allow him to proceed but what we are trying to say is even if we proceed, 9 members of a committee consumed 3Million, even when you people you go out I always have tabulation, committee clerk such an amount of money, Speaker such an amount, MCA such an amount, how many days, venue then we indicate the figures, that is where the point is.

**Hon. Linda Kharakha:** Yes Mr. Speaker, I have no dispute on the questions and issues at hand, all I am asking is can the questions be read then we get the response then now get all the questions from Members?

**Mr. Speaker:** But when I was giving the response here I was very clear, we read question 1, get feedback, and then question 2

**Hon. Linda Kharakha:** Honourable Speaker at this point, it is looking like we are going back and forth, that is my concern.

Mr. Speaker: Hon. Nganga, I am coming back to you,

**Hon. Everton Nganga:** Honourable Speaker thank you, Hon. Sudi is disturbing me, protect me.

Mr. Speaker: You are protected proceed

**Hon. Everton Nganga:** Thank you Mr. Speaker, I am for the idea that if there are questions you give us time we ask questions and the number of questions you set if they are 4 or 5, you let him respond then we move on instead of interjecting all the time, we are jumbling him which is not correct.

**Hon. Kennedy Wanyama:** Thank you Mr. Speaker, my concern was that my question had not been answered; it was a direct question but is not yet answered.

Mr. Speaker: He was noting down, Hon. Makari

**Hon. George Makari:** Thank you, Hon.Speaker. I would like to say that actually we are unsettling the gentleman, let's be procedural. What we should do is leave him respond and if there is any interjection it should come from the mover of the question then any other interjection from us can now arise after the CEC. This CEC is ours, all of us are from Bungoma County, let's give him time to respond then from there the Leader of Majority can disturb him because he is

the owner of the question but the rest of us can wait until he is done. This guy is ours and I have never seen an honest man like him.

**Hon. Johnston Okasida:** I will be very brief, as we were passing messages to the students, we were saying that the purpose of education is critical thinking and I want to say this; you have just said that the document you are holding is not signed, the attachments are not certified, how do we proceed with uncertified documents? Why can't we allow the holder of the documents to take them and certify them and let him sign the documents so that when we are walking the journey we are walking on the same lane?

Mr. Speaker: Before we proceed because he did say that he will have them signed but they are his, he confirmed so if he has confirmed they are his, let's be able to allow him because this day is set aside for him. When we adjourn the next time he will be on the Order Paper may be next month. I asked him are they from your office and he said yes so I think lets allow him because if he has owned them. It would be something else but he has said he is sorry, they were prepared by his office but not all of them were signed.

**Hon. Johnston Okasida:** Honourable Speaker, picking up from where you have left, bank statements are not prepared from the department of Education, how will this particular person own them? How can we know that they were generated from the bank where they are purported to have come from.

**Mr. Speaker:** That being the position and if we go that direction we will have to stand him down because among the annexures behind here which is item number 2 in our statement here which says; Provide bank statements indicating withdrawals. He is saying he was given a soft copy.

Members question number 2 is talking about bank statements and you know how we always get it, if it is voluminous they can send it to your email you print it out but for this purpose, you may need to have one which is certified. You can get one on soft copy and even doctor it to look something else. But he is a good man he cannot be the one engaging in doctoring but since it has come here it is something else. Leader of Majority, you know some of the Members in this House know what is ought to be here

**Hon. Joseph Nyongesa** (**Leader of Majority**): Thank you Speaker, actually indeed we have a very active House. What Hon. Okasida is saying is right because this is just maybe a basis of building up a case and in future maybe if somebody disowns then we may not have an escape goat. Through our own wisdom and from what you have heard from members, let the CEC own them by signing because we are looking at misuse of funds and the documents are not certified so my kind request...

Mr. Speaker: Honourable members, the challenges we are having here are very interesting, the CEC will sign his part but the problem is he is not the fund administrator, he is not the fund administrator from the record neither is he the chairperson of the board or the fund, I am sure of that so he will sign his part as the CEC Education then now what happens on the next pages? The area which is important is the fund administrator, so members I think whichever way you want

us to go about it, this document must be certified by him, he will just take this one to the bank they certify and bring it back, have the fund manager and chairman append signatures. With what is being raised by members, we cannot proceed.

**Hon. Joseph Nyongesa:** The committee members also should sign the activities they did so that no one is used as a scape goat. When you go down to the Wards what we know is 65 but they have said 75 also the Ward administrator should own it.

**Mr. Speaker:** Let us allow the CEC time to go and prepare and bring a proper response because what you are saying just like in your committees when you have done an activity there is an attendance sheet that you always sign.

(Loud consultations)

Order Members

Honourable chairperson of education what is the issue? I have seen you want to speak.

**Hon. Benjamin Otsiula:** Sorry Hon. Speaker, I concur with your ruling and I am not about to say anything contrary. I have seen information coming round the way members are raising questions, it is very important that those questions are responded to. However, I realized that some of the questions being put to the CEC cannot be responded to at this particular time as much as he is going to respond to the statement raised by the Leader of Majority and other questions coming in between.

I also wish to urge members that when we have CEC responding to questions and in future if he is not in a position to respond to a particular question he should own up and seek for more time so that we don't find ourselves in this scenario.

Otherwise, your ruling is sound, let the CEC be given time to provide details and do a breakdown as per each particular event so that it can save him time while presenting the issues.

Hon. Jack Wambulwa: Honourable Speaker, I also want to concur with the ruling that you are yet to make especially now that we are proposing we give the CEC enough time so that he can go and prepare a valid report that will have been authorized by him, signed and confirmed for it to be taken serious by this house. In addition to what you are just saying, there are recipients who were receiving this money and for purposes of transparency and accountability it will be good that we also confirm that even these committee members at the Ward level did actually sign and confirm that they received the money. That way it will be very easy for you my brother the CEC so that it is easy for you to confirm that indeed this money was not misappropriated, these are the Members who received from each ward, and this is the much received on particular dates. That way it will move us somewhere, otherwise I want to concur Speaker.

**Mr. Speaker:** Honourable Members, I see you still want to speak but to cut this thing short, let us allow the CEC go look at the question and answer the way it is. To be very honest, when you

come here and you are asked what was not in the statement you can't answer it, let us stick to the questions in the statements and allow him to answer the way it is.

Secondly, CEC this document is not mine, when I leave, it is going to be put in our archives here as a record, but it is not signed. If I knew it was not signed from the onset, we couldn't have allowed you to come and respond to it. Luckily, we allowed you but I remember I chased the CEC of Health over the same issues, you must own it so that when we ask you it becomes your document.

Honourable Members, allow me give the CEC time because we are discussing something that happens, he goes and prepares the documents properly. You people always get your bank statements online but I think he thought having that one is sufficient, unfortunately, when you come before the House, they must be stamped and signed by the bank officers. The way you go before PAIC committee, you must have stamped records not the one you have been able to access online.

For fairness, we allow the CEC more time; we will want to give him two weeks. CEC just take your time, bring us the report so that when you are here we are able to look at the items straightforward and move on; but, if they come the way they are, you will be hammered with a question that you will not be able to believe in and I think that is the best way forward.

Since you are here, I will give you up to  $26^{th}$  October, a Thursday at 2:30pm. Take your time, the week starting on  $23^{rd}$ , you can send me a report we share with Members; we look at it so that when you come here you clarify issues. When you come with such a statement, I am the worst because I have been going to court and we know whenever you go to court you must have signed documents that you are able to defend anytime you are asked to. Thank you we allow you to leave and we wish you well this coming weekend.

#### (e) County own Generated revenue

The report does not indicate what the County managed to collect as own generated revenue in the period under review except Mabanga ATC reporting a collection of Kshs.18, 395,495. The Public Sector Accounting Standards Board requires separate revenue reporting for counties. AIA is a component of county own source revenue reported under the County Receivers of Revenue Statements.

The Public Sector Accounting Standards Board further requires selected entities like Level 4 and 5 health facilities to report separately. Its revenue is reported in the respective financial statements.

#### (f) Other grants

On the grants from development partners and National government, an actual amount of Kshs. 489,256,980 was remitted to the county as grants for implementation of the following programmes:

- i. Sscholarship and other educational benefits Kshs. 200,000,000.
- ii. other capital grants and transfers Kshs. 289,256,980

#### (g) Account receivables

The accounts receivables (outstanding Imprest) across all departments amounted to Kshs. 294,183,471 against a balance of Kshs.46, 734,145 in year 2021/2022. However the comparative figure cannot be ascertained because 9 departments did not have any figure for the financial year 2021/2022.

Finance and Economic Planning department has the highest outstanding Imprest at Kshs. 144,557,460 followed by Office of the Governor and Deputy Governor at Kshs. 35,111,650. The list of individual officers holding unaccounted Imprest in every department as given in the report.

The department has Accounts payable (Pending bill) outstanding amount of Kshs. 287,662,821 against a budget provision of Kshs. 28,979,503. The largest percentage of this pending bills is staff pension payable to Lap fund and Lap trust. During the supplementary budget, the

department was allocated Kshs.248, 365,000 towards staff pension. A total of Kshs.48, 193,744 was paid towards offsetting this balance in the period under review.

#### DEPARTMENTAL EXPENDITURE ANALYSIS

The department of Finance and Economic planning had an annual approved budget of Kshs. 1,633,584,329 broken down as Kshs.1, 477,716,444 recurrent and Kshs.155, 867,884 development. The allocation to the various directorates is as below:

#### a) Economic Development Planning and Coordination services

The directorate was allocated Kshs.131, 466,381 and as at 31<sup>st</sup> March, 2023 the total expenditure was Kshs.115, 489,598 which translates to 88% absorption.

#### b) Monitoring & Evaluation Services

The directorate was allocated Kshs.57, 370,773, and during the period under review the total expenditure was Kshs.50, 580,703 translating to 88% absorption.

#### c) General Administration, Planning, Policy coordination and Support Services

The directorate was allocated Kshs.1, 288,879,290 and the expenditure during the period was Kshs.831, 103,867 translating to 64% absorption

#### **Development Expenditure**

The amount allocated to development was Kshs.155,867,884 with an absorption of Kshs.35,132,572 (23%) ,broken down as follows:

- i. Revenue system Kshs.35m
- ii. Emergency fund Kshs.102,298,000
- iii. ICT and Networking Equipment Kshs.5m
- iv. Supplier credit Kshs.13,569,884

#### **Committee Observation and Recommendations**

#### **Observation**

- 1. The County treasury did not indicate how much each department received as exchequer release to implement their programmes in the period under review. The reason for this is that the format of presenting the report does not allow the breakdown to be given
- 2. Other sources of revenue (other receipts) that make up 181 Million were not disclosed.

- 3. The report did not indicate what the County managed to collect as own source revenue in the period under review because it is given in the receivers of revenue report.
- 4. The report did not break down the grants received from the different development partners Kshs. 289,256,980.
- 5. Development vote in the budget had an allocation of Kshs.155,867,884, which was stated as emergency fund Kshs 102,298,000, revenue system 35,000,000, purchase of ICT networking Kshs 5,000,000 and supply of credit Kshs 13,569,884 yet in this report the same is indicated as Ward based projects with 23% absorption
- 6. The outstanding Imprest was Kshs 294,183,471 compared to Kshs.46, 734,145 previous year although the comparative figure cannot be ascertained because 9 departments did not indicate their figures.

#### **Committee Recommendation**

The committee recommended that:

- 1. The county Treasury should give amount of money disbursed to every department in the report going forward
- 2. The County Treasury should disclose the make-up of other receipts totaling to Kshs.181 Million immediately after the adoption of this report.
- 3. The treasury should break down the grants received from different partners by name and amount.
- 4. The County departments should adhere to the Imprest surrender period in line with the provisions of Regulation 93(5) of the Public Finance Management (County Governments) Regulations 2015 in regard to Imprest management and have all Standing Imprest fully accounted for by 30<sup>th</sup> June, 2023 as directed by the County Treasury circular.
- 5. The department of Finance and Economic Planning should comply with section 114(1) (2)(3) of the Public Finance Management Act 2012 on emergency Funds. The department should come out clear on whether this allocation of Kshs. 155,867,884 is for development or Ward based projects.

Surrender of Imprest is guided by Regulation 93(5) of the Public Finance Management (County Governments) Regulations, 2015. The County Treasury through circular No. 1/2023 dated 17<sup>th</sup> January, 2023 guided all accounting officers of county departments and entities to ensure imprests are surrendered on time. Standing Imprest is expected to be fully accounted for by 30<sup>th</sup> June, 2023.

We have some annexures, that is the adoption of the minutes and 9 month Financial Statement F/Y 2022/23 for the period ended  $31^{st}$  March.

We have the adoption schedule; we the undersigned members affix our signatures adopting this report with the contents there in. I think I went through the membership of the committee and all the members have signed the report. At this juncture, I wish now to call upon Hon. Aggrey Mulongo to second the motion.

**Hon. Aggrey Mulongo:** Thank you Mr. Speaker sir for giving me this chance to second the motion. I wish to thank the mover of the motion, the chairperson of my powerful committee. First and foremost, I thank all the members. Secondly, I want to thank you Mr. Speaker and your team for giving us time to come up with a very wonderful report. When you look at this report, imprests are Kshs.294Million, that is not small money, and if Kshs.294Million is there, what does the PFM Act talk about it? 7 days, if it is 7 days, why are the departments not following up the people to surrender the imprests?

Secondly, Finance or treasury if it is not going to work well with departments taken we are going to have lapses in our development. I second the motion.

(Motion proposed)

**Hon. Kennedy Wanyama:** Thank you Mr. Speaker for giving me an opportunity to contribute to this report of 9 months from the department on Finance and Economic Planning. I am extremely disappointed; this department is in charge of economic planning and more so it is a department that ensures compliance.

I want to touch on three areas, the first area is receivables and on receivables I want to dwell on the issue of imprests. Mr. Speaker this department is actually leading with an imprest of Kshs.144Million; this is despite of several advisories from the national treasury and very clear guidelines from the PFM Act. We have professionals manning this department and I just do not understand how and why this is happening.

The second area is on payables; on the area of payables again the department is leading with Kshs.287Million and more worrying is that most of these staff pensions that is what has been captured in the report. If it staff deductions or payment to creditors all these items have timelines. Why isn't the department effecting these timelines that have been provided for?

The third one and the most disappointing is the issue of the emergency fund; we appropriate a lot of money through this Assembly for this purpose; it is absurd that this department does not provide statements of expenditure. Procedurally even after spending this money the department is supposed to bring back those statements to this House ratification unless I am wrong. I am disappointed on those three areas and this department needs to pull up its socks. I thank you.

**Hon. Johnston Ipara:** Thank you Hon. Speaker. First of all let me laud Hon. Mukhongo for presenting the way it is supposed to be. I want to talk on three issues; the first on one emergency fund as provided for by the Public Finance Management Act; it says that "either after you have used that money or you intent to use the money you will after you have used present that expenditure to the County Assembly for approval". Hon. Speaker for the last one year and one

month that we have been in this Assembly I have never seen this. I want to urge the chairperson to state on how they are going to make this particular department comply with the requirements of the Act.

Two; declaration of funds to each department; my do we make this a confidential matter? Why do we make it a top secret? Why can't we declare that we have given this money to the department of Agriculture, we have given this money to the department of Trade for this purposes. This will create accountability, transparency and it will also show the entire of the county that this department was given and they were unable to do what they were supposed to do.

Lastly, you have seen from the first and today I want to believe this is the 7th document that is presented on a statement of account for the last 9 months. It is repeated; imprest mismanagement continuous and don't forget this is a department that is supposed to guide and give revenue and finance policy on management of imprest. You are told that when you go on a journey on returning back one thing that you are supposed to do is to surrender the imprest that you have taken for that particular journey. Why does it take the holder of the imprest over months to surrender? How was it accumulated to Kshs. 140 million? Does it mean that this particular money was allocated to this department without clear purposes? If it had clear purposes and people went on a genuine journey, why are they unable to account for this money within the required of 7 days? I rest my case Hon. Speaker.

Hon. James Mukhongo (Chairperson Finance): (Mover to reply) thank Hon. Speaker. From the onset allow me laud Honourable members who have contributed to the motion. I also in particular thank the members of Finance and Economic Planning Committee and I promise to the House that we have taken charge of the department. We have agreed with my members who can bear witness that we are not looking aside in terms of compliance. I want to confirm to the members that yesterday we received the end year financial expenditure report where every department will look at its department. I beseech that we must emphasize on the issue of non-surrender of imprest. Looking at our report we have given those timelines to comply with after adoption of this report.

On the issue of emergency funds, it has been a disease since I entered this House, year in year out they have never given a report on how they have expended funds from this fund. It is a resolving fund which is not meant to be consumed and we forget about. It must be consumed and replaced so that when we have an emergency elsewhere, we can draw money from the same fund. However, I wish to submit that we have told the CECM Finance that when we will be interrogating our fourth quarter financial expenditure report that is one of the areas; as we will be bringing our report we must have attachments of the same expenditure and how they have

planned to refund back. If they fail even as a House we will sanction the relevant laws to put them on task so that they can work.

I promise and agree that I am the chairperson of the committee and we have a membership that belongs to the government side but our cardinal role here is oversight to the executive. Therefore, we are not going leave anything.

Otherwise, I wish to request the members to adopt this report as it is so that some of the recommendations we are putting fourth can be implemented. I submit Mr. Speaker.

In sub-clause 1(g) by deleting it in its entirety.

Hon. Jeremiah Kuloba: I second the amendments.

**Hon. Johnston Ipara:** Thank your chairperson for the opportunity. I was trying to read this one "enforcing the compliance", do we enforce the compliance or we enforce Bungoma County laws, regulations and policies to ensure compliance? Is it compliance that we enforce or is the law that we enforce together with the regulations? Which one comes first?

Hon. Stephen Wamalwa (Chairperson Committee of the Whole House): That is a debate that is arising and it is open for the plenary. I would like the veteran members the likes of Mukhongo to be keen with this and every other member because it is important. You realize that the proposed amendments were brought forward by the Chairperson of the Committee who is sitting which were seconded. The Hon. Ipara has raised and issue which opens the plenary, I hope we are together? Hon. Ipara are you done?

**Hon. Johnston Ipara:** Hon. Chairperson, I want to request the learned friends in this House my daughter Hon. Linda and Hon. Otsiula to guide on this one. Do we enforce compliance or we enforce the law?

**Hon. Johnston Ipara:** That is why I have asked every one of us to be keen with the proceedings. Do we have Hon. Linda in the House? May be I have to put on my glasses to see where she is. I can see her now. Hon. Mukoyandali?

**Hon. Job Mukoyandali:** Thank you Mr. Chairman. I thought the clause is just clear that we are enforcing the compliance. What we are looking at is the execution bit of it. We are putting weight on the end product.

**Hon. Johnston Ipara:** These are issues used by those who go to courts, the advocates of the High Court. Hon. Okasida has been working closely with them in some quarters. Hon. Otsiula was mentioned also and he is here.

**Hon. Benjamin Otsiula:** I'm sorry Chairperson. I came in when the senior Hon. Chemion was on his feet. It will be bad manners to contribute to a topic or matter at hand which you are not well versed of. From my knowledge we always enforce the law to ensure compliance.

**Hon. Johnston Ipara:** Thank you Hon. Otsiula. Therefore, I request that the Hon. Otsiula and Hon. Linda, you remain in the House to the end. Members, ensure that the two members are here until the end. Hon. Chemion who is standing in for the Chairperson Public Administration, you have a chance to reply to this to enable us proceed.

**Hon. Francis Chemion:** Than you, Hon. Chairperson. We came up with this and our issue was on compliance of the law and we saw that the law was not being complied with. Therefore, we came up with the word enforcing this law so that it is complied with. That was the reason Hon. Chairperson.

(Question proposed)

The ayes have it

Hon. Okasida, resume your seat. Honourable members, I have guided you that you have to be keen so that we move together at every level. May I take you through this, that after we propose a question, it means we are opening up the plenary that is when the chairman read the proposed amendments and called in his seconder. Now at that level, it is a window when Hon. Okasida Ipara brought in the concern. The discussion has been there and I have called the move to replay and he has done so, therefore, we cannot go back. - (g) Nature and manner of recordings to be maintained by the inspectorate
- (h) Handling of all impounds.

I call upon Hon. Jeremiah to second the amendment.

**Hon. Jeremiah Kuloba:** Thank you Chairperson. I stand to second the proposed amendments on Clause 12.

(Applause)

Hon. Okasida, what is it?

**Hon. Johnston Ipara:** Hon. Chairperson, just get comfortable with me because we must assist this county make good laws that make sense. Nature and manner of recordings to be maintained. You cannot maintain recordings, you maintain records and I believe this is a typo error.

**Mr. Chairperson:** Hon. Okasida, you cannot put the cart before the horse. This is a House of rules and procedures and in normal circumstances when the mover has moved and seconded, what follows? I have to propose a question. Therefore, you are running first. That is why I am saying that I am comfortable with you always.

Hon. Johnston Ipara: Thank you Chairperson for the observation.

(Question proposed)

**Hon. Johnston Ipara:** Thank you, Mr. Chairperson. This is a learning session. I want to seek for clarification from the chairperson of the committee on what they meant. Because they are saying nature and manner of recordings to be maintained by the inspectorate. I want to believe that this must have been a typo error where they wanted to say records. If it is a typo error I propose an amendment on this to change from "recordings" to "records".

**Mr.** Chairperson: Hon. Okasida, when you propose an amendment automatically you also call a seconder because it is a motion within a motion.

**Hon. Johnston Ipara:** Hon. Chairperson, I call upon Hon. Linda to second the amendment.

**Hon. Linda Kharakha:** Hon. Chairperson, I second the amendment to change "recordings" to "records" so as to read "the manner and nature of records to be maintained by the inspectorate".

(Question proposed for an amendment within an amendment)

**Mr. Chairperson:** Honorable members, you have to look at it so that you can make an informed decision. Delve into it and see if Hon. Okasida and Hon. Linda are right.

**Hon. Francis Chemion:** Thank you, Hon. Chairperson. I look at the word "recordings" which is used here which means to store sounds or moving pictures using electronic equipment so that they can be heard or seen later. Hon. Chairperson these recordings are key for the directorate especially if they are going to charge a person in a County Court. They will require the recordings. Therefore, they can take pictures of whatever they have impounded and present them

to the court. Thus they record and store which they may us later in charging the offers of the law. I think that is the perception of the author of this bill.

**Mr.** Chairperson: Honourable members, look at the context of the clause so that we don't alter and confuse. Hon. Mukoyandali you can proceed.

**Hon. Job Mukoyandali:** Thank you Chairperson. Just the way you have put it, in this particular case we are looking at the context of the use of the word "recordings", our county *Askaris* mostly they are working within our Central Business Centre (CBD)...

**Mr. Chairperson:** Honourable members, let us follow so that we get the context. I beg that you are keen on this and I equally request that you don't leave.

**Hon. Job Mukoyandali:** Hon. Chairperson, the context is that when I am being accused of parking the vehicle wrongly, what would be the evidence that they will relay on that indeed I parked the vehicle wrongly? In this regard, they can present some pictorial evidence showing that they are not mere allegations but it is true that I parked the vehicle wrongly. Therefore, the word "recordings" has been used rightly Hon. Chairperson.

**Hon. Ken Wanyama:** Thank you, Mr. Chairperson. I think the issue should be what was the intention of the drafters? They are only looking at electronic data or it also includes manual, because if it includes the manual records as well, then the use of the word "records" will make more sense. If it is strictly on electronic records, then "recordings" will make more sense. Thank you.

**Mr. Chairperson:** Thank you members, I want to say this for your information. I will allow Hon. Linda to contribute courtesy of the Committee of the Whole House, if it was a normal plenary she will not. Hon. Linda, proceed.

**Hon. Linda Kharakha:** Thank you, Mr. Chairperson. I want to blow my mind on the nature of the intention of the writer was meant is gathering evidence. Therefore, we do away with the use the words "handling recordings" so that say "handling of evidence gathered" so that we are cutting across from any nature of the documents whether physical or live recordings to ensure that we are not limited to recordings only in that matter. I'm looking at it in terms of maybe they have impounded goods then it will either video recording which is live or even statements being put down on the nature of the goods. Maybe if we moved away from saying recordings as to how I asked earlier that we propose its records then we can move to now evidence gathered so that it's cutting across.

**Mr.** Chairperson: Thank you Hon. Linda. Hon. Aggrey, then I will put the question. The mover will reply after that. Hon. Waliaula Mulongo Aggrey!

**Hon. Aggrey Mulongo:** Thank you Chair. When you look at the statement itself and then you go to 12 (h), its answering 12(g). Why am I saying that? When you look at recording when you are going to handle all impounds those are goods and goods are recorded not recordings but they are recorded so it means we must have records. The word there is records not recordings.

**Mr. Chairperson:** Well, I now call upon the mover of the motion within a motion to reply. Hon. Ipara!

Hon. Johnstone Ipara: Thank you Chair. I want first of all to thank the contributors who have said this and Honourable Chair when you read 12 you find that its saying recordings and we normally maintain records and when you go to 12(h) it confirms actually what was required. If you impound goods, they are in different nature either perishable or non-perishable or permanent in nature so where do you record them. You record them in a register and these registers in summary are referred to as records and maybe let me read from the oxford dictionary; records means any written or recorded information regardless of physical form or characteristics which is produced or acquired by the party in the performance of this agreement and it tells you further records produced or acquired in a readable machine.

I am answering what he said because the Chair said that he was targeting maybe recording things on a digital but records confirm that records produced or acquired in a machine readable electronic format shall be maintained in that form and that form is record and I wanted to plead with the Chair, we are nor underrating the language used, we are only assisting so that when our enforcement agents are called to answer on issues in court, actually they will be able to produce the records which maybe in the form of a register or maybe in form of a digital recording in a disk so all of them are classified as records and I want to plead with this Honourable House to assist the department have laws that they are able to enforce and we shall have people to comply with it.

**Mr. Chairperson:** Thank you, Hon. Ipara. Honourable members, a motion having been moved and duly seconded and debate having ensued, I now put the question that clause 12 paragraph (g) be amended by replacing the word recordings with record.

(Question put and agreed to)

**Mr. Chairperson:** Honourable members, I now propose the question which is that clause 14 be part of the Bill and proceed to call upon the mover to proceed with amendments. Hon. Masai!

**Hon. Francis Chemion:** Thank you Chair, I now move that Clause 14 of the Bill be amended by inserting the words 'By surrender them to the police ' immediately after the words in custody in sub clause (d) so as to read 'to arrange for the proper sustenance and shelter of every person who is under arrest or in custody by surrendering them to the police'

I call upon Hon. Makhanu to second the amendment.

Mr. Chairperson: Hon. Cornelius Makhanu, proceed!

Hon. Cornelius Makhanu: Thank you Honourable Chair, I stand to second the proposed amendment.

**Mr. Chairperson:** Thank you, Hon. Makhanu.

And most of the chairs sought for 21 days but they were allowed 14 days by the Speaker and going by the number of the statements that are before the committees, it's prudent that we allow the committees have enough time we adjourn the plenary so that honorable members have good time to interrogate the executive so that they avail this reports within the stipulated period. businesses of this house are generated by the committees and therefore by adjourning this house to allow this committee process those statements and any other report. Hon Speaker we will be able to have enough fodder for us in this honorable House. So I want to second that we adjourn from 12th to 24th Tuesday October, 2023 at 2 30 p.m., and the reasons are well given, I second.

**Mr. Speaker:** Thank you, Hon Chemion. Honorable members, allow me now to propose the motion because it is a procedural motion. I must propose the motion for the honorable members to debate if they have the energy so that we are able to have at the end of it the House making a decision over the same. Honorable members, a motion having been moved and seconded that this house resolves to adjourn its sittings from today the Thursday 12<sup>th</sup> October, 2023 to Tuesday 24<sup>th</sup> October, 2023 at 2 30 p.m. to allow the committees to process the pending business before them. I propose. Yes Hon Job proceed.

(Question proposed)

**Hon. Job Mukoyandali:** Hon. Speaker, looking at the work ahead most of the pending matters are of the County importance. I support the motion.

Mr. Speaker: Thank you. Hon Meshack.

today Thursday 12<sup>th</sup> October, 2023 to Tuesday 24<sup>th</sup> October, 2023 at 230 p.m. This is to allow the committees process and clear all the pending businesses before them.
