Hon. Anthony Luseneka: Thank you, Hon. Speaker. I am here to move a motion on the Selection Committee report on the adjustment of committee's membership.

Background

Article 186 of the constitution provides that the legislative authority of the County is vested in and exercised by its County Assembly. County Assembly may make laws that are necessary for the effective performance of the county functions and while respecting the principal, the separation of powers may exercise oversight over the County Executive, Committee and any other County Executive organs

Section 14(1)(b) of the County Government Acts states that , A County Assembly may establish committees in such a manner that and for such general or special purposes as it considers fit and regulate the procedure of any committee so established.

The county assembly of Bungoma Standing orders provides for the establishment of 24 committees and there mandates have been specified. Standing Order No. 174 c2 mandates the committee on Selection to nominate members to serve in committees, except membership of the House Business Committee, Committee on Appointment and members of the Speakers Panel.

I take this opportunity to request Hon. James Barasa Mukhongo to second the report.

Hon. James Mukhongo: Thank you, Hon. Speaker. I stand to second the motion that has been presented before this House. While we were doing this work we put into consideration our Standing Order 176(1) which if you allow me I can read: If nominating members to serve in a select committee the committee on selection shall ensure that the membership of the committee reflects the relative majorities of the seats held by each of the County Assembly parties in the County Assembly.

That was our point of reference when we were nominating members to serve on various committees and nominating members to serve on the committees in this House is purely a prerogative of the parties as it is ably stated here in our Standing Orders. Most of our work was to consult even with the leadership of the parties that belong to this Honourable House.

Otherwise, I stand to second the motion.

Mr. Deputy Speaker: Thank you, Hon. Mukhongo for seconding the motion. Hon. Members allow me propose a motion for debate.

(Motion proposed)

Hon. Allan Nyongesa: Thank you, Hon. Speaker. First, allow me appreciate the Committee on Selection led by the Leader of Majority and Leader of Minority for trying to balance members in committees. However, the seconder read 176 of our Standing Order but I want to challenge him also to open 175(2) which says: The Committee on Selection shall give consideration to the need for gender balance and shall, so far as may be practicable, ensure that no more than two-thirds of members of a Committee of the County Assembly, including a Committee established through a resolution of the County Assembly, shall be of the same gender.

Honourable Speaker, this one I am directing it to the Committee on Liaison, as it is constituted we are missing out on Gender balance, we are only having Hon. Violet Makhanu as the Chairperson of Youth and Sports and the Vice Chairperson of the Committee. We only have two women out of 20 members in that committee. Therefore, I want to challenge the honourable ladies on the Majority to stand up for their rightful share. We also need to give honourable members who are women to be in leadership in this House.

I also have an issue on the Budget Committee in regard to Standing Order 210 (3) where it says "in nominating members under paragraph 2, the Committee on Selection shall nominate a member from each sub county and 2 members representing either youth, women, minority or people living with disability.

On the Committee of Budget, we have two members from Bumula Sub County, 2 members from Kanduyi Sub County, 2 Members from Webuye and 2 members from Kabuchai. There is no member from Tongaren and Kimilili. There is no member representing the special interest; no disability, no youth and no woman who was specially elected. With that I have my reservations and I oppose this report.

Hon. Aggrey Mulongo: Thank you, Mr. Speaker. I also stand to say if it means balancing, whatever the Selection Committee went for was balancing. What kind of balancing is it at the moment if the positions for Kimilili and Tongaren are not there? Is this balancing? How come that out of 9 sub counties 2 sub counties don't have representation on the Budget Committee and this is our Standing Order which we should comply with. If that is the bible of this House that is supposed to guide us, then we are supposed to look into it.

When you look at Standing Order No. 176 which is elaborate and up to now if I may say is that on CAF representation; it is only Kenya Kwanza who are being represented and not the minority side. It is not part of this but we need to balance. It is not part of this report but the laws that we are supposed to follow we are going contrary to them.

Hon. Jeremiah Kuloba: Thank you, Mr. Speaker. When I look at Standing Order 209 (3) it states that "no chairperson of any other committee should be a member of Budget Committee". I think we should also look at that. At the same time we get members who are in Budget Committee who are County Assembly Service Board and again they are members of PAC. PAC is there to do its own work.

Mr. Deputy Speaker: Hon. Kuloba, I got more confused. I did not understand, Budget, PAC. Make your point understood. I don't know if I am confused.

Hon. Jeremiah Kuloba: You are not confused it is just that some people are making noise...

Mr. Deputy Speaker: Order members, consult in low tones so that Hon. Kuloba can make his point clear.

Hon. Jeremiah Kuloba: If you can open Standing Order 209 it states that members of Budget Committee should not be chairpersons of any other committee...

Mr. Deputy Speaker: Can you read the same. Which 209? Are you sure Hon. Kuloba on 209. Is it 209 or 210?

Hon. Jeremiah Kuloba: It is 210.

Mr. Deputy Speaker: But you were referring to 209.

Hon. Jeremiah Kuloba: It was a misrepresentation. It is supposed to be 210.

Mr. Deputy Speaker: What was the point Hon. Kuloba?

Hon. Jeremiah Kuloba: Mine is about the membership of the committee that no chairperson of any other committee should be a member of the said committee. I rest my case.

Mr. Deputy Speaker: Hon. Kuloba, I would like you to substantiate and name the chairperson who is a member of the Budget Committee or you withdraw.

Hon. Jeremiah Kuloba: I want a hard copy of the report which has not been supplied. I request that a hard copy is supplied to me so that I go through it.

Mr. Deputy Speaker: Honourable member, you are out of order. Allow me finish with all due respect. You know well that a report has been circulated to every member. It means you gadget has a problem and you are contributing on something that you don't know. Therefore, you have to withdraw so that it is expunged from the HANSARD.

Hon. Jeremiah Kuloba: I withdraw. Thank you, Mr. Speaker.

Mr. Deputy Speaker: I'm seeing Hon. Godfrey Mukhwana yet the one sited there is Hon. Namaemba?

Hon. Violet Makhanu: Thank you Mr. Speaker. I want to say something but the problem is that we don't have this report on our gadgets. It is order that we get such report early enough to be able to understand what is happening...

Mr. Deputy Speaker: Hon. Namaemba you going on record that you don't have this report and may be you have not opened your email because the report was circulated. If some members have it, then those that don't have it means your gadgets have a problem. Therefore, we should not go on record...

Hon. Violet Makhanu: Mr. Speaker, I have never lack bundles on my phone. I mean what I say that I don't have the report on my gadget the reason why I am concerned because I wanted to have a look at it. It is in order that we look at it; yes the committee has done its part and it is their right to do what is supposed to be done and balance the way the seconder of the motion indicated.

Mr. Deputy Speaker: Honourable I want to ask that we are going on record not for this year but for posterity and the future. Therefore, our allegations or unconfirmed statements should be correct. The report was circulated so we cannot make assertions the report is not circulated because it will be captured wrongly yet it is not the true position.

For those whose gadgets have not downloaded the same, it is not the problem of any other member, it is your problem that you check your gadget and seek the assistance from the IT department of the Assembly. So that if you gadget has a problem; in fact you should have done that before you came in; so that you have to read and when we come here you are at the same level. Hon. Kuloba what is it?

Hon. Jeremiah Kuloba: Mr. Speaker, I have always indicated that I am analogue and I have always requested to be given hard copies so that I can go through page by page. It is a request that I made in this House, therefore, my rights are being violated over the same.

(Applause)

Mr. Deputy Speaker: Very well. The rights of Hon. Kuloba are being violated but I demand that he returns the Tablet because he is analogue; return the Tablet to the Assembly so that you are given hard copies.

Order members!

When you claim that, you must be aware that you are going on record. If it is true that you are analogue, it means you are not using it because it was given to us to use it for this purpose and not any other purpose. The Tablet is supposed to receive the Order Paper and everything about the plenary. That is true Hon. Mulongo and you have to adhere to that.

Order members!

You may use your phone yes but the Tablet is actually meant that all the transactions of this plenary come through that. Therefore, if you cannot use it, then you have to make a record at the Clerk's Office that you are not able to use it, then, they will consider you as a special case in this respect. What I am saying is correct and it is a guidance Hon. Kuloba.

Hon. Jeremiah Kuloba: I understand but from the word go when I was being sworn in this House; they knew that I was analogue not digital and they gave me the tablet. Why did they give it to me? I rest my case.

Mr. Deputy Speaker: They did not know that you are analogue.

(Loud Consultation)

Order Hon. Members, Order members!

Honourable Kuloba, can you resume your seat please!

Order members!

When we come here Hon. Members, the County Assembly cannot assume that one or many of us are analogue or digital. They assume that we are at the same level with the contemporary issues, so if you have a problem then you register the same. What I am advising Hon. Kuloba and any other person who has deficiency in that area, that you register the same with the relevant office remedial action can be undertaken.

Order members!

Hon. Kuloba, you have to prove that you are really analogue and you cannot even operate your phone. Let's proceed!

Let me call the mover to reply!

Hon. Antony Lusenaka: Thank you, Hon. Speaker. I want to take this opportunity to appreciate those members who have contributed to the motion and I assure this House that whatever has been raised will be considered in the committee, so that we comply with the Standing Orders and rules of this House.

On the issue of gender balance, I know we have a challenge and from the minority side there is nothing much that we can do. On the majority side, I know they will do something about the Gender balance so that we comply with Standing Order 175.

On the issue of the Budget committee, it is also a Coalition issue and I think each coalition shall have time to make sure that they comply.

About Standing Order No. 210 which was raised by Hon. Jeremiah Kuloba, I do not think there is a Chair of any committee that is in Budget committee apart from the Chair of the Budget Committee. I think that one was misplaced, we have complied with Standing Order 210. We cannot be perfect, this is work in progress and each coalition will sought out any challenges that they may face in the course of discharging the duties as per the Standing Orders.

Mr. Deputy Speaker: Thank you, Hon. Antony Lusenaka. Hon. Members, a report having been moved, duly seconded and debate having ensued and reply made, I therefore put a question that this house adopts the report by the Committee on Selection on the adjustments of the committee's membership laid on the table of the house on the 8th Day November 2023.

(Question put and agreed to)

The ayes have it.

The same is adopted and Hon. Members, under Standing Order No. 177 (2) it means that this report and the contents there in takes effect immediately. Therefore, with that we adhere to the same.

Hon. Members, we were to go back to Order No. 7 but we will strike it off the Order Paper of the day completely so that we shall handle the same on our 21st day when we resume here.

Mr. Deputy Speaker: Hon. Barasa Mukhongo!

Hon. James Mukhongo: Thank you, Hon. Speaker. Under Standing Order No. 152(2), I move a motion that the Bill be now read a third time. Hon. Chemion to second!

Mr. Deputy Speaker: Hon. Chemion!

Hon. Francis Chemion: Thank you, Hon. Speaker. I second the reading of the Bungoma County Finance Amendment Bill 2023 for the third time.

Mr. Deputy Speaker: Hon. Members, the Bill having been seconded, I now propose a question that the Bungoma County Finance Amendment Bill 2023 be read a third time. I propose.

Now, Honourable members, I put the question that the Bungoma County Finance Amendment Bill 2023 be read a third time!

(Question put and agreed to)

The ayes have it .The Bill shall be read a third time

An amendment Bill for an Act of the County Assembly of Bungoma to provide for revision of various tax, fees and charges for the service and for revenue raising measures by the County Government and for matters incidental there to-3rd reading

Mr. Deputy Speaker: Hon. members, a Bill having been read a third time, it's now considered to have been enacted, it becomes an act of the County Assembly of Bungoma and it will be transmitted to the office of the Governor for assent so that it can be useful to this County. Within the stipulated period of time it should be transmitted to the office of the Governor for the assent being the act of the County Assembly of Bungoma. Thank you.

Hon. Members, there is an emerging issue where we have a petition from *Emonywo Yefwe* international on market construction for mobile traders at Dina Flyover Webuye. This is under petitions and I want to allow Hon. Psero who is the owner of this so that you can give the House progressive report on the same. You can proceed!

Hon. Jacob Psero: Thank you, Mr. Speaker. The Hon. Speaker, County Assembly of Bungoma. Through the office of the clerk County Assembly of Bungoma

Reference: Progress report on the petition by *Emonywo Yefwe* international on market construction for mobile traders at Dina Flyover Webuye.

Pursuant to Standing Order No. 225(2) which states that whenever a petition is committed to Justice Cohesion and Legal Committee, it shall by not more than 60 calendar days respond to the

petitioner by way of report addressed to the petitioner or petitioners and laid on the table of the House. The petition was tabled on the floor of the House on 12th September 2023 and will be due for tabling on 12th November 2023.
