The *Bamasaba* and the *Bukusus* are not just neighbors; we are keenly linked by blood, language and common destiny. Our fore fathers forged a relationship grounded in mutual respect, cooperation and deep understanding of our cultural values.

Let us all be reminded of the powerful role the cultural leadership plays in preserving our identity and fostering unity. Your Highness, your leadership of *Bamasaba* has been exemplary and inspired by your commitment to promoting cultural awareness, education and the wellbeing of your people. Your visit here underscores the significance of the cultural diplomacy in straightening the ties that bind us.

Your Highness, in Bungoma County, the *Bukusu* community cherishes its cultural heritage and we recognize the importance of maintaining our customs and traditions in the face of modern challenges. Your visit provides us with an opportunity to reflect on our shared heritage and to explore ways in which we can collaborate for the benefit of our communities. Together, we can address issues such as education, health care, economic development and cultural preservations. By fostering ties between the *Bamasaba* and the *Bukusus*, we can build a bright future for our children and ensure that our rich culture and legacy is passed down to our future generation.

Your Highness, as you grace us with your presence, we are reminded of the words of our elders; a child does not grow her way up in isolation but within the embrace of the community. Let us therefore embrace this opportunity to strengthen our bonds to learn from each other and to walk together in the path of progress and mutual respect. Thank you all for coming to this House.

## QUESTIONS AND STATEMENTS

**Mr. Speaker:** Honourable members, I think this is the time; I will allow members to make a few remarks concerning our visitors in the Public Gallery and the Speaker's Gallery.

**Hon. Stephen Wamalwa:** Thank you Hon. Speaker for according me this opportunity to make a remark on this very auspicious day. First of all, I wish to welcome and thank His Highness the *Omukuka* for choosing to come and pay a courtesy call to this very important institution. Where we sit, we understand that we are a family that was put aside by the colonial boundaries which were forceful; but as a people, we are excited that this is a direction that makes sure and reminds us that as a people, today we are overcoming the boundaries that were set by the colonial powers in this region. That there is hope that in future, our children will understand our origin, will understand that we are a people who lived and existed together.

Your Highness, this is a place that was set up by the colonial powers, those people who actually demarcated the boundaries that set apart the *Bamasaba* and the *Bukusu* people; but today, we are here sitting in this building and we know that going forward, we are going to teach our people. I was very keen when the *Omukuka* said that we are slaves, he didn't use these words but I can tell you I took that very strongly. We are slaves because none of us, especially the *Bukusu* nation in Kenya is teaching our children the *Bukusu* language. We pride ourselves in speaking English and Kiswahili, we take courses up to PHD level learning the linguistics of English and Kiswahili and other linguistics but we forget the very first language of our fore fathers.

As I finish, I want to implore the Gender and Cultural Committee in this House with the help of the administration and leadership of this Assembly through the Heritage Act; that inclusion of fostering our language is given prominence so that we can move forward and make sure that our language is not going to be extinct. If we are not careful, even the *Bukusu* language will be extinct with time.

I want to welcome you Your Highness. We are here and we are excited with your entourage. As you travel back, we pray for your journey mercies. Thank you Hon. Speaker.

**Hon. Metrine Wilson:** Thank you Hon. Speaker for giving me this golden opportunity to appreciate our visitors in a special way. I wish to first appreciate His Highness the King, *Owelukosi Omukuka* the third for appointing me to be one of His Cabinet Members as a special envoy on Social Solidarity, Cultural Institutional Development and Reforms.

(Applause)

Before I proceed, I would like our members to know that His Highness is accompanied by cabinet ministers...

**Mr. Speaker:** Honourable Member, stick to the contributions. I have done the communication

**Hon. Metrine Wilson:** Yes, thank you Speaker. I would like to say that *Enzu ya Bamasaba* comprise of *Bakisu* and *Bukusus* and it was founded in 1962. The first king was Mugoma during

colonial times and Obote times and it was abolished by His Excellence Amin and reinstated by His Excellence Museveni in 1995. Our first king during His Excellence Museveni was His Highness Wilson Wamimbi and the second one was His Highness Bob Mushikoli. Now we have His Highness Jude Mike Mudoma.

Hon. Speaker, I now go back to my contribution. It is with immense pride and great honour that I stand before you today to welcome His Highness *Owelukosi Omukuka* the third, Jude Mike Mudoma the revered cultural leader of *Bamasaba* community to the County Assembly of Bungoma. His presence alongside his esteemed delegation is a testament to the enduring bonds of friendships and cultural heritage that unite our communities across the border of Kenya and Uganda. The *Bamasaba* community with their rich traditions and cultural heritage has always been a beacon of resilience and pride. Your leadership, Your Highness; serves as a guiding pride for many illuminations; the path of cultural preservation, education and community development. We are deeply honoured to host you and we look forward to the insights and wisdom you will share with us.

I wish to extend our gratitude to His excellence Hon. Kenneth Makelo Lusaka, the Governor of Bungoma County for inviting our *Omukuka* to visit this great county. I also extend my heartfelt thanks to you Hon. Emmanuel Mukhebi Situma, the Speaker of the County Assembly of Bungoma for welcoming the King and His delegation to this House.

The *Bamasaba* cultural institution also known as *Enzu ye Bamasaba* exists to preserve our culture, protect land rights and conserve the environment amongst other contemporary and emerging issues like education and health. In our rapidly changing world, it is essential that we hold first to our cultural roots and values. They are the foundation upon which we build our identities and our future. As leaders and custodians of our heritage, we have a profound responsibility to protect and promote our cultural legacy for...

**Mr. Speaker:** Honourable Member you will have to wind up please...

**Hon. Metrine Wilson:** ...yes I am winding up Hon. Speaker. I would like to acknowledge the contributions of the *Bamasaba* community to the socio-economic and cultural tapestry of our region. Your entrepreneur spirit, education and unwavering commitment to community development have significantly enriched our society. In our Cabinet, our king also embraces education. Last year in October, he even visited the Wales University in the United Kingdom and the team from Wales University even came back to reciprocate our King's visit and they are willing to promote education by giving scholarships and to even promote youth sports by offering training scholarships; especially those who are not talented in academics.

**Mr. Speaker:** You will have to wind up we have a budget ahead us.

**Hon. Metrine Wilson:** They are also willing to donate some money to build our museums which will also preserve our heritage.

*(Applause)*

Now that we are a family, I would like you to allow us some time in your own wisdom that Gender and Culture Committee visits to benchmark on the same. Equally, I support the sentiments of the Hon. Deputy Speaker on enacting a legislation and coming up with policies that support culture in our area. With those few remarks I submit and welcome your Highness.

**Hon. Caleb Wanjala:** Thank you Hon. Speaker. Basing on the work ahead of us, I will also join my colleagues in appreciating His Highness the King of *Bamasaba* for coming to Bungoma County. Indeed this shows that Africa is one and we need to work together. If you go in Uganda, you will realize that we share names, culture and everything. Mine was just to welcome him to this County.

**Hon. Jack Wambulwa:** Asante Ndugu Spika. Nachukua hii fursa kwanza kumkaribisha kiongozi wetu ambaye ni *Omukuka* kutoka taifa la Uganda aliyekuja kututembelea. Sisi jamii ya Bukusu ni ndugu wa jamii Bagisu kule Uganda. Historia inatueleza kwamba mtu Mbukusu na Mgisu walikuwa mandugu lakini mipaka iliyowekwa na wakoloni ndio iliyotutenganisha. Ningependa kuchukua hii fursa niseme karibu sana ndugu *Omukuka* kwa sababu sisi kama jamii tungependa tutembeleane kila mara pasipo na vikwazo vya aina yoyote

*(Applause)*

Nao wanatutembelea pasipo na masharti yoyote hasa hapa jambo kubwa ambalo tuko nalo kila mara tunapo jaribu kuoa dada zetu kutoka kule Abagisu inakua ni changamoto kupata kitambulisho. Hilo ni jambo ambalo tunatakikana tulishughulikie kiserikali; tuhakikishe kuwa jamii ya Wabukusu na Bagisu tutembeleane na tufanye biashara ili kuinua uchumi wa maeneo yetu. Ndugu Spika, huu mwaka mnajua ni mwaka wa kutuunganisha kupitia *embalu*. *Embalu* huwa inatuleta pamoja wakati tunakuwa na sherehe mwezi wa nane. Nataka kusihi kwamba ikiwezekana, sisi kama wajumbe tutenge fedha kiasi fulani ili tuweze kutembelea ndugu wetu wa Uganda na kushiriki sherehe hiyo na hao pia waweze kuja hapa kwetu. Karibu ndugu *Omukuka*.

*(Applause)*

**Hon. Tony Khaoya:** Thank you Hon. Speaker. First I wish to confirm to this House that I am the immediate neighbour of *Omukuka*; bordering Uganda through Lwakhakha and with the integration of East African Community, I want to laud the *Omukuka* leadership that has brought about the integration and unity among the Bukusu clan and the Bagisu group in Uganda. It is high time as the community that we embrace the unity and diverse culture between the two countries. I wish also to confirm that through the leadership of *Omukuka* we have a unified people of integrity from both Kenya and Uganda. I summarize by saying *papa Omukuka wateka khwola Mukenya* (our King, we thank you for coming to Kenya).

*(Applause)*

**Hon. Hentry Nyongesa:** Thank you Hon. Speaker. I take this opportunity to welcome His Highness with his delegation, as well as our own; Her Excellency Deputy Governor. I want to echo the sentiments made by Honourable Members in welcoming his Highness to Bungoma County and in particular in this House. I wish to bring to your attention that Bungoma County is rich in culture. It produced the largest number of fighters during the colonial war. We have areas which are essential for purposes of culture and learning of our children. There was war in Lumboka and Myanga where our forefathers died fighting the colonial rule.

Hon. Wambulwa has mentioned about *Embalu* (circumcision) ceremony that is normally held in Mbale, Uganda. I have gone to this place severally to visit my brothers and sisters and I can confirm that this ceremony is held at a place called Emutoto; promoting our culture specifically circumcision.

This country hosts an area called *Mwiyala Wa Mango* where the Bukusu circumcision history begun. The center is in Malakisi and I request His Highness the King of *Bamasaba* that during cabinet deliberations; they consider *Mwiyala Wa Mango* and make it a cultural centre. Instead of always going to Emutoto for *Embalu*, *Mwiyala Wa Mango* can also host this ceremony interchangeably with Emutoto in Uganda.

Your Highness, as you visit this country, these are some of the areas that you should consider visiting with your delegation. We also have Chetambe in Webuye which is equally historical; just to mention but a few. I wind up by welcoming you to this county *Omukuka*.

**Hon. Edwin Opwora:** Thank you Mr. Speaker for giving me this opportunity. It would have been very bad if I could not have spoken because *Omukuka* the King has hosted me as his guest in Mbale and I also want to thank him for visiting Bungoma. Bungoma is just part of his region I want to thank him for considering some of our people in his cabinet like Hon. Wakoli Bifwoli, who is a resident in my Ward, Hon. Mureka who is also my grandfather and Hon. Nangila who is a Member in this House. This shows the consideration of the King of Bamasaba and the importance of the people of Bungoma to his Kingdom.

I wish to highlight the importance of Bungoma as a town in regards to the economic value of the *Bamasaba* as a region. Right now, we have an airport that is going to be of importance; not only to the people of Bungoma, but also to the people *Masaba*.

We have the Immigration Office in Bungoma and as Hon. Wambulwa said, it is important that we start considering our brothers from across as part of our family and if there is need, they should be given an opportunity to get passports from the Bungoma office so that they are counted as part of this region. Let us not segregate these communities based on the colonial boundaries. We are still a family and let us live with love and continue with the culture that shows respect to our people and also rich in terms of tourism.

**Hon. Jeremiah Kuloba:** Asante Ndugu Spika kwa kunipa nafasi hii. Kwanza kabisa Mfalme napenda kukukaribisha katika mji huu kwa kutambua kuwa mji wa Bungoma ni kati ya himaya ya ile miji ambayo unatawala. La pili na la mwisho, leo asubuhi kabla hujaja nikamuuliza mzazi wangu na akaniambia huyo mfalme anakuja ndiye baba yako; akirudi huko, hakikisha umerudi akuonyeshe kipande cha shamba chako huko Uganda.

(Applause)

Tena mamangu akaniambia, angalia Mfalme miguu yake na uangalie miguu yako; jinsi unatembea ni miguu ya huyo Mfalme.

**Hon. Everlyne Achieng':** Thank you Mr. Speaker. I am on my feet not as one of the *Bamasaba*; but a woman married here and a wife to the *Bamasaba*. I want to take this opportunity to welcome His Highness the leader of the *Bamasaba* to this House and I do not have many



vocabularies or many Bukusu vocabularies, but I just want to send you back with the greetings to the leader of the *Iteso*- which is my tribe the *Emormor*.

**Mr. Speaker:** Honourable Members, those who haven't had a chance to speak, let me take this chance on your behalf and say welcome once again to Bungoma County *Omukuka*. This is part of your Kingdom all the way from Mbale to this region.
