#### **Department of Agriculture, Livestock, Fisheries and Co-operatives Development**

In the department of Agriculture, Livestock, Fisheries and Co-operatives development, a sum of Kshs.605, 075,266 was granted and issued from the County exchequer account to meet the expenditure during the year ending 30<sup>th</sup> June, 2026 in respect of recurrent expenditure of Kshs.70, 058,405 and development expenditure of kshs.535, 016,861 in the department of Agriculture, Livestock, Irrigation, Fisheries and Co-operative Development.

#### **Department of Tourism and Environment**

The department of Tourism and Environment, a sum of Kshs.619,762,220 was granted and issued from the County Exchequer Account to meet the expenditure during the year ending 30th June, 2026 in respect of recurrent expenditure of Kshs.375,273,332 and development expenditure of Kshs.244,488,88 in the department of Tourism and Environment.

## **Department of Water and Natural Resources**

In the department of Water and Natural Resources, a sum of Kshs.803,734,474 was granted and issued from the County exchequer account to meet the expenditure during the year ending 30<sup>th</sup> June, 2026 in respect of recurrent expenditure of Kshs.45,315,674 and Development expenditure of Kshs.758,418,800 in the department of water and Natural Resources,

## **Department of Roads, Transport, Infrastructure and Public Works**

In the department of Roads, Transport, Infrastructure and Public Works, a sum of Kshs.1,337,914,299 was granted and issued from the County Exchequer account to meet the expenditure during the year ending 30<sup>th</sup> June, 2026 in respect of recurrent expenditure of Kshs.45,759,393 and development expenditure of Kshs. 1,292,154,906 in the department of Roads, Transport, Infrastructure and Public Works.

## **Department of Education and Vocational Training**

In the department of Education and Vocational Training, a sum of Kshs.259,245,737 was granted and issued from the County Exchequer account to meet the expenditure during the year ending 30<sup>th</sup> June, 2026 in respect of recurrent expenditure of Kshs. 93,653,953 and development expenditure of Kshs.15,591,784 in the department of Education and Vocational Training.

## **Department of Health and Sanitation**

Speaker, in the department of Health, a sum of Kshs.1,696,364,231 was granted and issued from the County exchequer account to meet the expenditure during the year ending 30<sup>th</sup> June, 2026 in respect of recurrent expenditure of Kshs.1,471,330,430 and development expenditure of Kshs.225,033,801 in the department of Health.

## **Directorate of Sanitation**

In the Directorate of Sanitation, a sum of Kshs 368,943 was granted and issued from the County exchequer account to meet the expenditure during the year ending 30<sup>th</sup> June, 2026 in respect of recurrent expenditure of Kshs 368,943 in the Directorate of Sanitation.

## **Department of Trade, Energy and Industrialization**

In the Department of Trade, Energy and Industrialization, a sum of Kshs 460,432,610 was granted and issued from the County exchequer account to meet the expenditure during the year ending 30<sup>th</sup> June, 2026 in respect of recurrent expenditure of Kshs 78,293,442 and Development expenditure of Kshs 382,139,168 in the Department of Trade, Energy and Industrialization.

A sum of Kshs 123,766,170 was granted and issued from the County exchequer account to meet the expenditure during the year ending 30<sup>th</sup> June, 2026 in respect of recurrent expenditure of Kshs 27,674,947 and Development Expenditure of Kshs 96,091,223 in the Department of Lands, Urban and Fiscal Planning.

### **The Bungoma Municipality**

In the Municipality of Bungoma, a sum of Kshs 119,640,398 was granted and issued from the county exchequer account to meet the expenditure during the year ending 30<sup>th</sup> June, 2026 in respect of recurrent expenditure of Kshs 44,248,371 and Development expenditure of Kshs 75,392,027 in the Bungoma Municipality.

### **Kimilili Municipality**

The Municipality of Kimilili, a sum of Kshs 130,786,275 was granted and issued from the county exchequer account to meet the expenditure during the year ending 30<sup>th</sup> June, 2026 in respect of recurrent expenditure of Kshs 43,690,318 and Development expenditure of Kshs 87,095,957 in the Kimilili Municipality.

### **Directorate of Housing**
