AN ACT of the County Assembly of Bungoma to amend the Bungoma County Revenue Administration and Management Act, 2019 and for connected purposes

ENACTED by the County Assembly of Bungoma, as follows—**Short title**

1. This Act may be cited as the Bungoma County Revenue Administration and Management (Amendment) Act, 2023 and shall come into force upon publication in the *Gazette*.
